**AMENDMENT OF SECOND SCHEDULE TO JUDGES'
REMUNERATION ACT, 1990**

Under the powers vested in me by section 3 of the Judges' Remuneration Act, 1990 (Act No. 18 of 1990), and on recommendation of the Judicial Service Commission, I hereby amend, with retrospective effect from 1 April 1998, the second column of the Second Schedule to that Act, by-

- a) substituting the amount of "N\$290 000" for the amount "N\$225 000" in respect of the Chief Justice;
- b) substituting the amount of "N\$287 000" for the amount "N\$222 000" in respect of an additional judge of the Supreme Court;
- c) substituting the amount of "N\$285 000" for the amount "N\$220 000" in respect of the Judge President; and
- d) substituting the amount of "N\$277 000" for the amount "N\$212 000" in respect of an additional judge of the High Court.

**AMENDMENT OF REGULATIONS MADE UNDER
THE JUDGES REMUNERATION ACT, 1990**

The President has under section 5 of the Judges' Remuneration Act, 1990 (Act No. 18 of 1990), made the regulations set out in the Schedule.

SCHEDULE

1. In this Schedule, "the Regulations" means the Regulations made under the Judges Remuneration Act, 1990, as promulgated by Government Notice No. 76 of 15 November 1990 and as amended by Government Notice No. 65 of 29 April 1994.

2. Regulation 3 of the Regulations is amended by the substitution in paragraph (a) of subregulation (1) for the amount "N\$4000,00" of the amount "N\$5000,00".
3. The amendment effected by this Schedule shall be deemed to have come into operation on 1 April 1998.
