## ACT

# To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2008.

(Signed by the President on 22 June 2007)

**BE IT ENACTED** by the Parliament of the Republic of Namibia, as follows:

#### Appropriation of amounts of money for financial requirements of the State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2008 as a charge to the State Revenue Fund.

#### Short title

2. This Act is called the Appropriation Act, 2007.
