## ACT

### To amend the Merchandise Marks Act, 1941.

(Afrikaans Text signed by the Governor-General.)  
(Assented to on 28th March, 1946.)

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:

Amendment of  
section 10 of  
Act 17 of 1941.

1. Section ten of the Merchandise Marks Act, 1941, is hereby amended by the substitution for paragraph (c) of sub-section (1) of the following paragraph:—

“(c) there shall be applied to them in a conspicuous manner and as specified in the notice, words stating clearly the materials of which they are composed and the percentages of such materials calculated either by weight or by volume as prescribed in the notice.”

Short title.

2. This Act shall be called the Merchandise Marks Amendment Act, 1946.

## ACT

### To apply a sum not exceeding forty million pounds on account of the service of the Union for the year ending the thirty-first day of March, 1947.

(English Text signed by the Governor-General.)  
(Assented to on 28th March, 1946.)

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £30,000,000. on Revenue Account and £10,000,000 on Loan Account.

Sums issued under this Act to be advances in anticipation.

1. On and after the first day of April, 1946, there may be issued out of the Exchequer Account such sums of money not exceeding in the aggregate the sum of thirty million pounds for revenue services and ten million pounds for loan services, as may from time to time be required for the service of the Union for the year ending the thirty-first day of March, 1947, until such time as provision is made therefor by Parliament in an Appropriation Act.

2. All sums issued under the provisions of this Act shall be deemed to be advances on account of grants to be made by Parliament in an Appropriation Act for the year ending the thirty-first day of March, 1947, and immediately on the commencement of such Appropriation Act, this Act shall cease to have effect and issues already made hereunder shall be deemed to be issues under that Appropriation Act, and shall be accounted for in accordance with the provisions thereof:

Provided that no services upon which expenditure has not been duly authorized under an Appropriation Act during the year ending the thirty-first day of March, 1946, or for which there is no statutory authority, shall be deemed to be authorized under section one of this Act.

Short title.

3. This Act shall be known as the Part Appropriation Act, 1946.

1. Artikel tien van die Handelswaremerke-wet, 1941, word Wysiging van hierby gewysig deur paragraaf (c) van sub-artikel (1) te vervang artikel 10 van Wet 17 van 1941. deur die volgende paragraaf :

„(c) woorde wat duidelik verklaar uit watter stowwe hulle saamgestel is, en die persentasies van sulke stowwe bereken of volgens gewig of volgens volume, soas in die kennisgewing voorgeskryf word, moet op 'n opvallende wyse en soas in die kennisgewing bepaal word, op hulle aangebring word.”

DIT WORD BEPAAL deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

1. Op en na die eerste dag van April 1946, mag daar uit die Skatkisrekening sodanige somme geld uitgegee word van belas met gesamentlik nie meer nie as dertigmiljoen pond vir inkomste-Inkomsterekening dienste en tienmiljoen pond vir leningsdienste as wat van tyd tot tyd benodig mag wees vir die diens van die Unie vir Lengsrekening. die jaar wat eindig op die een-en-dertigste dag van Maart 1947, totdat die Parlement deur 'n Begrotingswet daarvoor voorsiening maak.

2. Alle somme kragtens die bepalings van hierdie Wet Somme ingevolge uitgegee, word beskou as voorskotte op rekening van geldte hierdie Wet wat deur die Parlement by 'n Begrotingswet toegestaan sal uitgegee, word word vir die jaar wat eindig op die een-en-dertigste dag van Maart 1947, en onmiddellik na die inwerkintreding van daardie Begrotingswet, tree hierdie Wet buite werking en word geldte wat kragtens hierdie Wet reeds uitgegee is, beskou as uitrekings kragtens daardie Begrotingswet en moet verantwoord word ooreenkomsdig die voorskrifte daarvan :

Met dien verstande dat dienste waarop gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1946, geen uitgawe behoorlik kragtens 'n Begrotingswet geoutorisieer is nie of waarvoor geen wetlike magtiging verleent is nie, nie beskou word deur artikel een van hierdie Wet gemagtig te wees nie.

3. Hierdie Wet heet die Gedeeltelike Begrotingswet, 1946. Kort titel.

## ACT

**To apply a further sum not exceeding three million four hundred and seventy-six thousand eight hundred and forty pounds towards the service of the Union for the year ending on the thirty-first day of March, 1946.**

*(Afrikaans Text signed by the Governor-General.)  
(Assented to on 28th March, 1946.)*

**B**E IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows :—

Exchequer Account charged with sums not exceeding £2,005,940 on revenue account.

1. The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1946, not exceeding in the whole the sum of two million five thousand nine hundred and forty pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1945 (Act No. 48 of 1945) and the Additional Appropriation Act, 1946 (Act No. 1 of 1946).

Exchequer Account charged with sums not exceeding £1,470,900 on loan account.

2. The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1946, not exceeding in the whole the sum of one million four hundred and seventy thousand nine hundred pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1945 (Act No. 48 of 1945) and the Additional Appropriation Act, 1946 (Act No. 1 of 1946).

How money to be applied.

3. The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Second Estimates of Additional Expenditure [U.G. 18—1946], as approved by Parliament, and to no other purpose.

Minister may approve variation.

4. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote : Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedule hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

Short title.

5. This Act shall be called the Second Additional Appropriation Act, 1946.

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

**1.** Die Skatkisrekening word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die inkomsterekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1946, maar gesamentlik nie meer nie as tweemiljoen vyfduisend nege-honderd-en-veertig pond, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1945 (Wet No. 48 van 1945) en die Addisionele Begrotingswet, 1946 (Wet No. 1 van 1946) belas is.

**2.** Die Skatkisrekening word verder belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die leningsrekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1946, maar gesamentlik nie meer nie as eenmiljoen vierhonderd-en-sewentigduisend negehonderd pond, benewens die somme waarmee bedoelde Rekening deur die Begrotingswet, 1945 (Wet No. 48 van 1945) en die Addisionele Begrotingswet, 1946 (Wet No. 1 van 1946) belas is.

**3.** Die geld deur hierdie Wet beskikbaar gestel, moet aan- gewend word vir die dienste opgenoem in die aangehegte Bylae en met meer besonderhede vermeld in die Tweede Begroting van Addisionele Uitgawes [U.G. 18—1946], soos deur die Parlement goedgekeur, en vir geen ander doel nie.

**4.** Met die goedkeuring van die Minister van Finansies mag 'n besparing onder die een subhoof van 'n begrotingspos aangewend word tot dekking van te grote uitgawe onder 'n ander subhoof of van uitgawe onder 'n nuwe subhoof van dieselfde begrotingspos: Met dien verstande dat die somme wat voorkom in kolom 2 van die Bylae tot hierdie Wet nie oorskry mag word nie en daarop gemaakte besparings ewemin aangewend mag word vir enige ander doel as waarvoor die geld hierby toegestaan word soos aangedui in die gemelde Bylae.

**CONSTITUTION OF SPECIAL HIGH COURT UNDER THE EMERGENCY REGULATIONS.**

His Excellency the Governor-General has, in terms of Regulation 2 (1) of the "Emergency Regulations", published in the Annexure to Proclamation No. 29 of 1942 (War Measure No. 13 of 1942) as amended by Proclamation No. 268 of 1945 (War Measure No. 87 of 1945), constituted a special High Court consisting of the Honourable Mr. Justice William Henry Ramsbottom, a Judge of the Transvaal Provincial Division of the Supreme Court of South Africa, as President and two Assessors to be selected from time to time by the said President of the Court, to try, in accordance with the provisions of these regulations, at any place in the Union or the Mandated Territory of South-West Africa, any person who has committed a special crime, as defined at any place in the Union or the said Territory or in any vessel registered in the Union or the said Territory.

The Minister of Justice has, in terms of Regulation 2 (2) of the "Emergency Regulations", published in the Annexure to Proclamation No. 29 of 1942 (War Measure No. 13 of 1942) as amended by Proclamation No. 268 of 1945 (War Measure No. 87 of 1945), appointed Mr. Fredrich Wilhelm Ludwig Guldenpfennig to be Registrar of the said special High Court, his official address being c/o The Registrar of the Supreme Court, Pretoria.

**INSTELLING VAN SPESIALE HOOGGEREGSHOF KAGTENS DIE NOODREGULASIES.**

Kragtens regulasie 2 (1) van die Noodregulasies wat in die bylae van Proklamasie No. 29 van 1942 (Oorlogsmaatreel No. 13 van 1942), soos gewysig by Proklamasie No. 268 van 1945 (Oorlogsmaatreel No. 87 van 1945), afgekondig is, het Sy Eksellensie die Goewerneur-generaal 'n spesiale hooggereghof ingestel, bestaande uit die Edelagbare William Henry Ramsbottom, Regter van die Transvaalse Proviniale Afdeling van die Hooggereghof van Suid-Afrika, as President, en twee assessore wat van tyd tot tyd deur genoemde President van die hof gekies moet word, om ooreenkomsdig die bepalings van hierdie regulasies op enige plek in die Unie of in die Mandaatgebied Suidwes-Afrika, enigeen te verhoor wat 'n spesiale misdaad, soos omskryf, op enige plek in die Unie of in genoemde gebied, of op enige vaartuig wat in die Unie of in genoemde gebied geregistreer is, gepleeg het.

Die Minister van Justisie het, ingevolge regulasie 2 (2) van die Noodregulasies wat in die bylae van Proklamasie No. 29 van 1942 (Oorlogsmaatreel No. 13 van 1942), soos gewysig by Proklamasie No. 268 van 1945 (Oorlogsmaatreel No. 87 van 1945), afgekondig is, Mn. Fredrich Wilhelm Ludwig Guldenpfennig, wie se amptelike adres p/a Die Griffier van die Hooggereghof, Pretoria, is, as Griffier van voormalde spesiale Hooggereghof aangestel.
