**Wet No. 40, 1976 WYSIGINGSWET OP NASIONALE VERKEERSVEILIGHEID,  
1976.**

## WET

**Tot wysiging van die bepalings van die Wet op Nasionale Verkeersveiligheid, 1972, met betrekking tot die jaarlikse verslag van die Nasionale Verkeersveiligheidsraad.**

*(Afrikaanse teks deur die Staatspresident geteken.)  
(Goedgekeur op 19 Maart 1976.)*

**D**AAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Vervanging van artikel 23 van Wet 9 van 1972.

**1.** (1) Artikel 23 van die Wet op Nasionale Verkeersveiligheid, 1972, word hierby deur die volgende artikel vervang:

„Verslae deur Raad. **23.** (1) Die Raad moet so gou doenlik na 31 Desember in elke jaar aan die Minister 'n verslag voorlê waarin besonderhede verstrek word aangaande—

- (a) die uitwerking van wetgewing beoog in subartikel (1), of van regulasies beoog in subartikel (2), van artikel 26;
- (b) sy werksaamhede gedurende die jaar wat op daardie datum eindig; en
- (c) enige ander aangeleentheid wat die Minister hom versoek om in die verslag te behandel.

(2) Elke verslag in subartikel (1) bedoel, moet vergesel gaan van 'n balansstaat en 'n volledige staat van die Raad se inkomste en uitgawe ten opsigte van die jongste boekjaar.

(3) Die Minister moet elke verslag, balansstaat en staat van inkomste en uitgawe wat ingevolge hierdie artikel aan hom voorgelê word, in die Senaat en in die Volksraad ter Tafel lê binne dertig dae na ontvangst daarvan, indien die Parlement dan in gewone sessie is, of, indien die Parlement nie dan in gewone sessie is nie, binne dertig dae na die aanyang van sy eersvolgende gewone sessie.”.

(2) Die bepalings van subartikel (1) is vir die eerste keer van toepassing ten opsigte van 'n tydperk wat op 31 Desember 1976 eindig, en vir die doeleinde van sodanige toepassing word die tydperk vanaf 1 April 1975 tot 31 Desember 1976 geag 'n tydperk van 'n jaar te wees.

Kort titel en inwerkingtreding.

**2.** Hierdie Wet heet die Wysigingswet op Nasionale Verkeersveiligheid, 1976, en tree in werking op 'n datum wat die Staatspresident by proklamasie in die Staatskoerant bepaal.

NATIONAL ROAD SAFETY AMENDMENT ACT, 1976.

Act No. 40, 1976

## ACT

To amend the provisions of the National Road Safety Act, 1972,  
relating to the annual report of the National Road Safety  
Council.

*(Afrikaans text signed by the State President.)*  
*(Assented to 19 March 1976.)*

BE IT ENACTED by the State President, the Senate and the  
House of Assembly of the Republic of South Africa, as  
follows:

1. (1) The following section is hereby substituted for section 23 of  
the National Road Safety Act, 1972:

Substitution of  
section 23 of  
Act 9 of 1972.

"Reports by 23. (1) The Council shall as soon as possible  
Council. after 31 December in each year submit to the  
Minister a report giving particulars as to—

- (a) the effect of any legislation contemplated in  
subsection (1), or of any regulations contem-  
plated in subsection (2), of section 26;
- (b) its activities during the year ending on that  
date; and
- (c) any other matter which the Minister may require  
it to deal with in that report.

(2) Every report referred to in subsection (1)  
shall be accompanied by a balance sheet and a full  
statement of the Council's income and expenditure  
in respect of the latest financial year.

(3) The Minister shall lay every report, balance  
sheet and statement of income and expenditure  
submitted to him in terms of this section upon the  
Table in the Senate and in the House of Assembly  
within thirty days after receipt thereof, if Parliament  
is then in ordinary session, or, if Parliament is not  
then in ordinary session, within thirty days after  
the commencement of its next ensuing ordinary  
session.”.

(2) The provisions of subsection (1) shall apply for the first  
time in respect of a period which ends on 31 December 1976,  
and for the purposes of such application the period from 1 April  
1975 until 31 December 1976 shall be deemed to be a period  
of a year.

2. This Act shall be called the National Road Safety Amend- Short title and  
ment Act, 1976, and shall come into operation on a date fixed commencement.  
by the State President by proclamation in the *Gazette*.
