Act No. 59, 1985 PREVENTION AND COMBATING OF POLLUTION OF THE SEA BY OIL AMENDMENT ACT, 1985

ACT

To amend the Prevention and Combating of Pollution of the Sea by Oil Act, 1981, so as to make other provision in respect of certain amounts to be paid into the Oil Pollution Prevention Fund; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 26 of Act 6 of 1981.

1. Section 26 of the Prevention and Combating of Pollution of the Sea by Oil Act, 1981, is hereby amended by the substitution for paragraph (a) of subsection (2) of the following paragraph: 5

“(a) as a charge to the **[State Oil]** Central Energy Fund referred to in section 1 (1) of the **[State Oil]** Central Energy Fund Act, 1977 (Act No. 38 of 1977), **[an amount calculated at the rate of 0,055 cents per litre of the customs or excise duty referred to in section 1 (1) (a) (ii) of the said Act or]** such **[higher]** amount as the Minister of **[Industries, Commerce and Tourism]** Mineral and Energy Affairs may, with the concurrence of the Minister, [approve in terms of the provisions of section 1 (2) (a) (ii) of the said Act] from time to time determine;” 15

Short title and commencement.

2. This Act shall be called the Prevention and Combating of Pollution of the Sea by Oil Amendment Act, 1985, and shall be deemed to have come into operation on 24 April 1985.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 26 van die Wet op die Voorkoming en Bestryding van Besoedeling van die See deur Olie, 1981, word hierby gewysig sig deur paragraaf (a) van subartikel (2) deur die volgende paragraaf te vervang:

Wysiging van artikel 26 van Wet 6 van 1981.

- 10 “(a) ten laste van die **[Staatsoliefonds]** Sentrale Energiefonds bedoel in artikel 1 (1) van die Wet op die **[Staatsoliefonds]** Sentrale Energiefonds, 1977 (Wet No. 38 van 1977), **[’n bedrag bereken teen die koers van 0,055 sent per liter van die doeane- of aksynsreg bedoel in artikel 1 (1) (a) (ii) van daardie Wet of]** die **[groter]** bedrag wat die Minister van **[Nywerheidswese, Handel en Toerisme]** Mineraal- en Energiesake, met die instemming van die Minister, **[ingevolge die bepalings van artikel 1 (2) (a) (ii) van daardie Wet goedkeur]** van tyd tot tyd bepaal;”.
