Die volgende Wet, wat ingevolge die Proklamasie op die Instelling van Wetgewende en Uitvoerende Gesag vir Suidwes-Afrika, 1985 (Proklamasie R.101 van 1985), deur die Nasionale Vergadering aangeneem en deur die Administrateur-generaal onderteken is, word hierby afgekondig ingevolge artikel 18 van daardie Proklamasie: —

DAAR WORD BEPAAL deur die Nasionale Vergadering, soos volg:

Wysiging van artikel 4
van Wet 14 van 1982.

1. Artikel 4 van die Wet op Karakoelpelse en Wol, 1982, word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

"(1) Die raad bestaan uit agt deur die **[Ministersraad]** Kabinet aangestelde lede van wie geeneen by aanstelling agt-en-sestig jaar oud of ouer is nie en van wie -

(a) vier produsente van karakoelpelse of wol in die gebied is **[van wie een ook lid van die Raad van die Karakoeltelersgenootskap is]**, deur die **[Ministersraad]** Kabinet gekies uit persone wat op sy versoek genomineer is deur 'n liggaam of organisasie wat na sy oordeel verteenwoordigend van sodanige produsente is;

(b) een ook 'n lid van die Karakoeltelersgenootskap van Suidelike Afrika (Noordelike Streek) is, deur die Kabinet gekies uit persone wat op sy versoek genomineer is deur die genoemde Karakoeltelersgenootskap van Suidelike Afrika (Noordelike Streek);

ACT

To amend the Karakul Pelts and Wool Act, 1982, so as to make other provision in relation to the constitution of the Karakul Board of South West Africa.

(English text signed by the Administrator-General on 9 July 1986)

BE IT ENACTED by the National Assembly, as follows:-

1. Section 4 of the Karakul Pelts and Wool Act, 1982, is hereby amended by the substitution for subsection (1) 5 of the following subsection:

Amendment of section 4 of Act 14 of 1982.

“(1) The board shall consist of eight members appointed by the [Council of Ministers] Cabinet, of whom no one shall be sixty-eight years or older on appointment and of whom -

10 (a) four shall be producers of karakul pelts or wool in the territory [of whom one shall also be a member of the Board of the Karakul Breeders Association], selected by the [Council of Ministers] Cabinet from amongst persons nominated at its request by any body or organization which in [the] its opinion [of such council] is representative of such producers;

15 (b) one shall also be a member of the Karakul Breeders Association of Southern Africa (Northern Region), selected by the Cabinet from amongst persons nominated at its request by the said Karakul Breeders Association of Southern Africa (Northern Region);

2. This Act shall be called the Karakul Pelts and Wool Amendment Act, 1986. Short title.
