# PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

### **ACT**

To amend the Townships and Division of Land Ordinance, 1963, so as to define the expression "'area' or 'area of jurisdiction' " and to further define the expressions "local authority", "Minister" and "Permanent Secretary"; and to provide for matters incidental thereto.

(Signed by the President on 15 June 2000)

**BE IT ENACTED** by the Parliament of the Republic of Namibia, as follows:-

Amendment of section 1 of Ordinance No. 11 of 1963, as amended by section 1 of Ordinance No. 36 of 1967, section 2 of Ordinance No. 10 of 1973, section 1 of Act No. 28 of 1992 and Act No. 21 of 1998

- 1. Section 1 of the Townships and Division of Land Ordinance, 1963 is hereby amended -
  - (a) by the insertion of the following definition after the definition of "approved township":
    - " 'area' or 'area of jurisdiction' means -
    - in relation to a municipal council, town council or village council the area declared under section 3 of the Local Authorities Act, 1992 (Act No. 23 of 1992) to be a municipality, town or village, as the case may be, or deemed to be so declared;
    - (b) in relation to a regional council, the area declared under section 31 of the Regional Council Act, 1992 (Act No. 22 of 1992) to be a settlement area.".
  - (b) by the substitution for the definition of "local authority" of the following definition:
    - "'local authority' means a municipal council, town council or village council as defined in section 1 of the Local Authorities Act, 1992 (Act No. 23 of 1992) or a regional council as defined in section 1 of the Regional Councils Act, 1992 (Act No. 22 of 1992);";
  - (c) by the substitution for the definition of "Minister" of the following definition:
    - " 'Minister' means the Minister of Regional and Local Government and Housing;"; and
  - (d) by the substitution for the definition of "Permanent Secretary" of the following definition:

" 'Permanent Secretary' means the Permanent Secretary:  $\underline{Regional\ and\ Local}$  Government and Housing;".

### **Short title**

2. This Act shall be called the Townships and Division of Land Amendment Act, 2000.
