## **ACT**

**To appropriate supplementary amounts of money to meet the additional financial requirements of the State during the financial year ending 31 March 2001.**

BE IT ENACTED by the Parliament of the Republic of Namibia, as follows:

### **1. Appropriation of amounts of money for financial requirements of the State**

Subject to the provisions of the State Finance Act, 1991 (Act [31 of 1991](#)), the amounts of money shown in the Schedule are appropriated as a charge to the State Revenue Fund for additional financial requirements of the State during the financial year ending 31 March 2001.

### **2. Short title**

This Act shall be called the Additional Appropriation Act, 2000.
