# **Appropriation Act, 2021**

## **ACT**

**To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2022.**

BE IT ENACTED as passed by the Parliament, and assented to by the President, of the Republic of Namibia, as follows:

### **1. Appropriation of amounts of money for the financial requirements of State**

Subject to the State Finance Act, 1991 (Act [No. 31 of 1991](#)) the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2022 as a charge to the State Revenue Fund.

### **2. Short title**

This Act is called the Appropriation Act, 2021.
