## ROADS AMENDMENT ORDINANCE, 1973

*(Assented to 5 July 1973.)*

*(Afrikaans text signed by the Administrator.)*

*(Date of commencement 26 July 1973 (except section 2).)*

# ORDINANCE

To amend the Roads Ordinance, 1972, in regard to the erection of gates in fences crossing proclaimed roads and the repeal of laws; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:-

Amendment of  
section 43  
of Ordinance  
17 of 1972.

1. Section 43 of the Roads Ordinance, 1972 (Ordinance 17 of 1972) — hereinafter referred to as the principal Ordinance — is hereby amended by the substitution for the proviso to subsection (1) of the following proviso:

“Provided that whenever any motor grid gate is erected in any fence crossing a proclaimed road in terms of the provisions of this subsection, a swing gate shall, unless the Executive Committee determines otherwise, also be erected in the road reserve of such proclaimed road in such fence.”.

Amendment  
of section  
70 of Ordinance  
17 of 1972.

2. (1) Section 70 of the principal Ordinance is hereby amended by the substitution for the proviso to subsection (2) of the following proviso:

“Provided that every proclaimed road proclaimed in terms of the provisions of any law prior to the commencement of this Ordinance shall continue to exist as it has thus been proclaimed and shall retain the classification and number allocated to it.”.

(2) Subsection (1) shall be deemed to have come into operation on the first day of January 1973.

Short title.

3. This Ordinance shall be called the Roads Amendment Ordinance, 1973.
