ROADS FURTHER AMENDMENT ORDINANCE,
1973.

(Assented to 27 November 1973.)

ORDINANCE

To amend the Roads Ordinance, 1972, in regard to the application thereof within the areas of local authorities; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

Amendment of the Classification of Ordinance 17 of 1972.

1. The Classification of the Roads Ordinance, 1972 (Ordinance 17 of 1972) — hereinafter referred to as the principal Ordinance — is hereby amended by the insertion after section 1 of the following section:

“1A. Application of Ordinance within urban areas.”.

Amendment of section 1 of Ordinance 17 of 1972.

2. Section 1 of the principal Ordinance is hereby amended by the deletion of the proviso to the definition of “proclaimed road”.

Insertion of section 1A in Ordinance 17 of 1972.

3. The following section is hereby inserted in the principal Ordinance after section 1:

“Application of Ordinance within urban areas.

1A. Only the provisions of sections 1, 3(2), 4(1), 22(1)(a), 22(3), 23, 24, 25, 26, 27, 28, 30, 31, 32, 36, 37, 39, 56, 57, 58, 59, 60, 61, 62, 65 and 68 of this Ordinance shall apply within an urban area: Provided that -

- (a) the provisions of sections 36, 37, 56, 57 and 62 shall within an urban area apply only to urban trunk and main roads maintained by the Executive Committee in terms of section 25;
- (b) the powers granted to the Executive Committee in terms of sections 30 and 37 shall only be exercised within an urban area in consultation with the local authority concerned;
- (c) the powers granted to the Executive Committee in terms of section 31 shall only be exercised within an urban area after consultation with the local authority concerned.”

Short title.

4. This Ordinance shall be called the Roads Further Amendment Ordinance, 1973.
