POSTPONEMENT OF THE COMMENCEMENT

ORDINANCE

To provide for the postponement of the commencement of the Municipal Dog Tax Amendment Ordinance, 1978, and for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:-

Repeal of Government Notice 305 of 29 December 1978.

Substitution of section 5 of Ordinance 8 of 1978.

1. Government Notice 305 of 29 December 1978 is hereby repealed and shall be deemed never to have been issued.

2. The following section is hereby substituted for section 5 of the Municipal Dog Tax Amendment Ordinance, 1978:

"Short title and commencement"

5. [(1)] This Ordinance shall be called the Municipal Dog Tax Amendment Ordinance, 1978, and shall come into operation on [a date to be determined by the Executive Committee and published by notice in the *Official Gazette*] 1 January 1980.

[(2) Different dates may be determined in terms of subsection (1) in respect of different provisions of this Ordinance.]".

Short title.

3. This Ordinance shall be called the Postponement of the Commencement of the Municipal Dog Tax Amendment Ordinance, 1978, Ordinance, 1979.

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN SOOS VOLG:-

1. Goewermentskennisgwing 305 van 29 Desember 1978 word hierby herroep en word geag nooit uitgevaardig te gewees het nie.
2. Artikel 5 van die Municipale Hondebelastingwysigingsordonnansie, 1978, word hierby deur die volgende artikel vervang:

Herroeping van Goewermentskennisgwing 305 van 29 Desember 1978.

Vervanging van artikel 5 van Ordonnansie 8 van 1978.

5. [(1)] Hierdie Ordonnansie heet die Municipale Hondebelastingwysigingsordonnansie, 1978, en tree op 1 Januarie 1980 in werking [op 'n datum wat deur die Uitvoerende Komitee bepaal en by kennisgwing in die *Offisiële Koerant* aangekondig word].

[(2) Verskillende datums kan ingevolge subartikel (1) ten opsigte van verskillende bepalings van hierdie Ordonnansie bepaal word.]".

3. Hierdie Ordonnansie heet die Uitstel van die Inwerkintreding van die Municipale Hondebelastingwysigingsordonnansie, 1978, Ordonnansie, 1979.
