PROCLAMATIONS

By HIS HONOUR DAVID GIDEON CONRADIE,
ADMINISTRATOR OF SOUTH WEST AFRICA.

No. 12 of 1936.]

WHEREAS by paragraph *four* of the Agreement concluded between the Administrator of South West Africa and the *Rehoboth* Community and the members of the *Rehoboth* Community, which said Agreement was ratified and confirmed by Proclamation of the Administrator dated the twenty-eighth day of September, 1923 (Proclamation No. 28 of 1923), it was agreed *inter alia*, that the Administrator, after consultation with the *Rehoboth* Community should possess the power to extend to the Territory referred to in the Agreement as the *Gebiet* the operation of any law in force in the Territory of South West Africa, if he considered such extension expedient or desirable in the interests of either the Territory of South West Africa or the *Gebiet*;

AND WHEREAS, by section *one* of the *Rehoboth* Affairs Proclamation, 1924 (Proclamation No. 31 of 1924), it was provided that, from and after the taking effect thereof, the *Rehoboth* should cease to function within the *Gebiet*, and that all and several the powers, functions and duties vested by law in the *Rehoboth* should vest in the Magistrate of the District of *Rehoboth*;

AND WHEREAS, after consultation with the Magistrate of the District of *Rehoboth*, the Administrator considers it expedient and desirable in the interests of the Territory of South West Africa and of the *Gebiet* to extend to the *Gebiet* the operation of the Motor Vehicle Ordinance, 1926 (Ordinance No. 9 of 1926), the Witchcraft Suppression Proclamation, 1933 (Proclamation No. 27 of 1933), the Extermination of Wild Dogs Ordinance, 1935 (Ordinance No. 6 of 1935), and the Meat Trade Control Ordinance, 1935 (Ordinance No. 8 of 1935);

NOW THEREFORE, under and by virtue of the powers in me vested, I do hereby proclaim, declare and make known as follows:—

The following laws, together with all amendments thereof or additions thereto which may hereafter be enacted, and all regulations which have been or may hereafter be made thereunder, shall be of full force and effect in the Territory referred to as the *Gebiet* in the Agreement contained in the Schedule to the Proclamation of the Administrator dated the twenty-eighth day of September, 1923 (Proclamation No. 28 of 1923), as amended by section *fourteen* of the *Rehoboth* *Gebiet* Affairs Proclamation, 1928 (Proclamation No. 9 of 1928):—

- (a) The Motor Vehicle Ordinance, 1926 (Ordinance No. 9 of 1926), as amended by the Licences, Wheel Tax and Motor Vehicle Licence Installments Ordinance, 1932 (Ordinance No. 1 of 1932);
- (b) The Witchcraft Suppression Proclamation, 1933 (Proclamation No. 27 of 1933);
- (c) The Extermination of Wild Dogs Ordinance, 1935 (Ordinance No. 6 of 1935);
- (d) The Meat Trade Control Ordinance, 1935 (Ordinance No. 8 of 1935), as amended by the Meat Trade Control Amendment Ordinance, 1935 (Ordinance No. 28 of 1935).

NADEMAAL deur paragraaf *vier* van die Ooreenkoms tussen die Administrateur van Suidwes-Afrika en die *Rehoboth*-Gemeente en die lede van die Raad van die *Rehoboth*-Gemeente en die lede van die Raad die voormelde Gemeente gestel, watter Ooreenkoms Proklamasie van die Administrateur, gedagteken die twintigste dag van September, 1923 (Proklamasie No. 28 van 1923) bevestig en bekragtig is, dit *inter alia* ooreen is dat die Administrateur, na rugspraak met die Raad die voormelde Gemeente, die bevoegdheid sou besit om wet wat in die *Gebiet* Suidwes-Afrika in werking is of landstreek, wat in die Ooreenkoms die *Gebiet* genoem uit te brei, as hy sodanige uitbreiding in die belang van die *Gebiet* Suidwes-Afrika of van die *Gebiet* raads wenslik ag;

EN NADEMAAL deur artikel *een* van "De *Rehoboth* Aangelegenheden Proklamasie, 1924" (Proklamasie No. 31 van 1924), bepaal is, dat vanaf en na die inwerkingtrekking van die Raad sou ophou om binne die *Gebiet* te funksioneer, dat al die bevoegdhede, funksies en pligte, deur die Raad verleen, by die Magistraat van die distrik *Rehoboth* sou berus;

EN NADEMAAL die Administrateur, na rugspraak die Magistraat van die distrik *Rehoboth*, dit raads wenslik ag in die belang van die *Gebiet* Suidwes-Afrika van die *Gebiet* om die werking van die Motorvoertuig Ordinasie 1926 (Ordinasie No. 9 van 1926), die Onderking van Towery Proklamasie 1933 (Proklamasie No. 27 van 1933) die Ordinasie betreffende die Uitroeiing Wildehonde 1935 (Ordinasie No. 6 van 1935) en die Ordinasie betreffende die Kontrole van Vleishandel 1935 (Ordinasie No. 8 van 1935) tot die *Gebiet* uit te brei;

SO IS DIT dat ek, op grond van en kragtens die voegdhede aan my verleen, hiermee proklameer, verklaar bekend maak, as volg:—

Die volgende wette, insaam met alle wysigings of byvoegsels daartoe wat hierna bekragtig mag word, alle regulasies wat in verband daarmee opgetrek is of hierna opgetrek sal word, is van volle krag en werking in die landstreek, wat in die Ooreenkoms bevat is, van die Proklamasie van die Administrateur gedagteken agt-en-twintigste dag van September 1923 (Proklamasie No. 28 van 1923), soos gewysig deur artikel *veertien* van *Rehoboth* *Gebiet* Aangelegenhede Proklamasie 1928 (Proklamasie No. 9 van 1928), die *Gebiet* genoem word:—

- (a) Die Motorvoertuig Ordinasie 1926 (Ordinasie No. 9 van 1926), soos gewysig deur die Ordinasie 1932 op Paaientjies van Lisensies, Wielbelasting Motorvoertuigbelasting (Ordinasie No. 1 van 1932);
- (b) Die Onderdrukking van Towery Proklamasie 1933 (Proklamasie No. 27 van 1933);
- (c) Die Ordinasie betreffende die Uitroeiing van Wildehonde 1935 (Ordinasie No. 6 van 1935);
- (d) Die Ordinasie betreffende die Kontrole van Vleishandel 1935 (Ordinasie No. 8 van 1935), soos gewysig deur die Wysigingwettensie betreffende die Kontrole van Vleishandel 1935 (Ordinasie No. 28 van 1935).
