### PROCLAMATION

BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA.

No. R. 90, 1962.]

AMENDMENT TO THE SECOND SCHEDULE OF THE WORKMEN'S COMPENSATION ACT, 1941 (ACT No. 30 OF 1941), AS AMENDED.

Under the powers vested in me by sub-section (2) of section *ninety-four* of the Workmen's Compensation Act, 1941 (Act No. 30 of 1941), as amended, I hereby declare that, as from the date of publication hereof, the Second Schedule to the said Act shall be amended:

1. (a) By the substitution for the words "Benzene, poisoning by" in the first column of the Schedule of the words "Poisoning by benzene or its homologues and their nitro and amino derivatives and its sequelae".

(b) By the substitution for the existing description of the corresponding occupation in the second column of the Schedule of the following description:—

"Any work involving the production or use of or contact with benzene or its homologues or their nitro and amino derivatives."

2. (a) By the insertion after the word "radium" in the first column of the Schedule of the words "and other radioactive substances".

(b) By the substitution for the existing description of the corresponding occupation in the second column of the Schedule of the following description:—

"Any work involving the use or exposure to the action of radium or other radioactive substances or X-rays."

LIMITS OF INTERFERENCE TO RADIO COMMUNICATION.

Published by the Postmaster-General in terms of Part 13 of the Radio Regulations.

(*Replaces regulations published in Government Gazette Notices No. 2561 of 30th December, 1955, and No. 557 of 14th April, 1961.*)

1. For the purpose of these limits:—

(a) *Distribution System* shall mean any system for conveying electrical energy from one place to another.

(b) *Noise Voltage at the Terminals* shall mean the noise voltage measured at the point where the apparatus is connected to the distribution system. Limits for the noise voltage at the terminals only apply where the declared distribution voltage is not greater than 750 volts between conductors or not greater than 375 volts between one conductor and earth.

2. *Measuring Equipment.*—The equipment to be used for the measurement of interference to radio communication shall be manufactured in accordance with C.I.S.P.R.<sup>(1)</sup> specifications contained in C.I.S.P.R. Publication No. 1 (for frequencies 150 to 30,000 kc/s) and C.I.S.P.R. Publication No. 2 (for frequencies 24 to 300 mc/s), or any subsequent amendments thereof or additions thereto.

3. *Limits of Interference.*—Table I shows the limits of interference which shall not be exceeded for the classes of equipment and systems listed hereunder. Where no limits are specified these limits have not yet been determined.

- (a) (i) Equipment, not covered by the classes below, which is designed for connection at its terminals to a distribution system having a declared voltage between conductors not greater than 750 volts or a declared voltage between any one conductor and earth not greater than 375 volts.
- (ii) Equipment, not covered by the classes below which is designed for connection at its terminals to a distribution system having a declared voltage between conductors greater than 750 volts, but not exceeding 15,000 volts or a declared voltage between any one conductor and earth greater than 375 volts, but not exceeding 15,000 volts.
- (iii) Equipment, not covered by the classes below, which is designed for connection at its terminals to a distribution system having a declared voltage between conductors or between any one conductor and earth exceeding 15,000 volts.
- (b) Equipment, not covered by the classes below, which is not connected to a distribution system (e.g. battery-operated equipment).
- (c) Motor vehicles and internal combustion engines.
- (d) Equipment intended for the generation of radio-frequency energy for industrial, scientific and medical purposes.
- (e) (i) Local oscillator radiation from Very High Frequency (V.H.F.) Frequency Modulation (F.M.) receivers for broadcast reception in the band 87.5 to 108 mc/s.
- (ii) Local oscillator radiation from all receivers not covered by (e) (i).

RADIOKOMMUNIKASJESTEURINGSGRENSE.

Gepubliseer deur die Posmeester-generaal ooreenkomstig Deel 13 van die Radioregulasies.

(*Vervang regulasies wat in Staatskoerantkennisgewings No. 2561 van 30 Desember 1955 en No. 557 van 14 April 1961 gepubliseer is.*)

1. Vir die toepassing van hierdie grense beteken:—

(a) *Distribusiestelsel*, enige stelsel vir die geleiding van elektriese energie van die een plek na 'n ander.

(b) *Ruisspanning by die eindpunte*, die ruisspanning geneem by die punt waar die apparaat aan die distribusiestelsel gekoppel is. Grense vir die ruisspanning by die eindpunte geld alleenlik waar die verklaarde distribusiespanning nie hoër as 750 volt tussen geleiers of nie hoër as 375 volt tussen een geleier en grond is nie.

2. *Meetuitrusting.*—Die uitrusting wat gebruik sal word om steurings aan radiokommunikasie te meet, moet vervaardig wees ooreenkomstig C.I.S.P.R.<sup>(1)</sup>-spesifikasies soos vervat in C.I.S.P.R.-publikasie No. 1 (vir frekwensies 150 tot 30,000 khz) en C.I.S.P.R.-publikasie No. 2 (vir frekwensies 24 tot 300 mhz) of enige daaropvolgende wysigings of byvoegings daartoe.

3. *Steuringsgrense.*—Tabel I dui aan die steuringsgrense wat nie oorskry mag word nie vir die klasse uitrusting en stelsels hieronder genoem. Waar geen grense gespesifiseer is nie, beteken dit dat grense nog nie vasgestel is nie.

- (a) (i) Uitrusting wat nie deur ondergenoende klasse gedeck word nie en wat ontwerp is om by die eindpunte gekoppel te word aan 'n distribusiestelsel met 'n verklaarde spanning tussen geleiers nie hoër as 750 volt nie of 'n verklaarde spanning tussen enigeen van die geleiers en grond nie hoër as 375 volt nie.

- (e) (i) Plaaslike ossillatoruitstraling van Baie Hoë Frekwensie (B.H.F.) Frekwensiemodulasie (F.M.)-ontvangtoestelle vir uitsaaiontvangs in die band 87.5 tot 108 mhz.
- (ii) Plaaslike ossillatoruitstraling van alle ontvangtoestelle wat nie in (e) (i) gedeck is nie.

- (f) Electrical traction systems:—

  - (i) Trolley buses, tramways.
  - (ii) Other traction systems.

(g) (i) Distribution systems having a declared voltage between conductors not greater than 750 volts or a declared voltage between any one conductor and earth not greater than 375 volts.

(ii) Distribution systems having a declared voltage between conductors greater than 750 volts, but not exceeding 15,000 volts or a declared voltage between any one conductor and earth greater than 375 volts, but not exceeding 15,000 volts.

(iii) Distribution systems having a declared voltage between conductors or between any one conductor and earth exceeding 15,000 volts.

(f) Elektriese traksiestelsels:—

  - (i) Elektriese busse, tremwää.
  - (ii) Ander traksiestelsels.

## LEERPLAN.

## 1. Romeins-Hollandse Reg.

Die Privaatreger van die Republiek van Suid-Afrika, aan die hand van gangbare handboeke, die geskrifte van die ou Romeins-Hollandsregtelike skrywers, die wetgewing en die regsspraak. Van kandidate word 'n deeglike kennis verwag gelykstaande met dié wat in die algemeen van LL.B.-studente verwag word.

Daar is drie vraestelle van drie uur elk, naamlik:—

## Vraestel 1.

Geskiedkundige agtergrond van die huidige Romeins-Hollandse Reg; Persone- en Familiereg.

Paper 2.

The Law of Things and the Law of Succession.

Paper 3.

The Law of Obligations, including the Law of Contract, Special Contracts and Delicts.

2. Statute Law.

There are two papers of three hours each, viz.—

Paper 1.

The Republic of South Africa Constitution Act, 1961 (Act No. 32 of 1961);

The State Liability Act, 1957 (Act No. 20 of 1957);

The Administration of Estates Act, 1913 (Act No. 24 of 1913); and

The Insolvency Act, 1936 (Act No. 24 of 1936).

Paper 2.

The Interpretation Act, 1957 (Act No. 33 of 1957);

The Vexatious Proceedings Act, 1956 (Act No. 3 of 1956);

The Supreme Court Act, 1959 (Act No. 59 of 1959);

The Magistrates' Courts Act, 1944 (Act No. 32 of 1944); and

The Criminal Procedure Act, 1955 (Act No. 56 of 1955).

The syllabus in Statute Law includes all amendments to and substitutions of the said statutes which have been promulgated at least six months prior to the date of the examination.

Candidates are expected to know the application and interpretation of the relative statutes as expounded in the decisions of the Supreme Court.
