AMENDMENT OF THE EXCHEQUER AND AUDIT ACT, 1975 (ACT 66 OF 1975), THE POST OFFICE ACT, 1958 (ACT 44 OF 1958), AND THE EXECUTIVE POWERS (POSTS AND TELECOMMUNICATIONS) TRANSFER PROCLAMATION, 1978 (PROCLAMATION AG. 12 OF 1978), SO AS TO PROVIDE FOR THE TRANSFER OF THE FINANCIAL AUTHORITY RELATING TO THE OPERATION OF THE DIRECTORATE OF POSTS AND TELECOMMUNICATIONS TO THE DIRECTORATE OF FINANCE AND FOR MATTERS CONNECTED THEREWITH

SCHEDULE

Amendment of section 1 of Act 66 of 1975, as amended by section 6 of Proclamation 85 of 1979

1. Section 1 of the Exchequer and Audit Act, 1975 (hereinafter referred to as the Act), is hereby amended —

- (a) by the deletion in subsection (1) of the definition of "Central Revenue Account";
- (b) by the insertion in the said subsection (1) in the definition of "revenue" after the words "this Act" of the words "or any other law"; and
- (c) by the deletion in the said definition of "revenue" of the words "the Post Office Fund and".

Substitution of section 2 of Act 66 of 1975, as substituted by section 7 of Proclamation 85 of 1979

2. The following section is hereby substituted for section 2 of the Act:

"Central Revenue Account and Post Office Account at Bank.

2. (1) There shall be maintained at the Bank —

- (a) an account to be known as the Central Revenue Account into which shall be deposited all State moneys, except revenue referred to in paragraph (b), and from which all expenditure shall be defrayed and all payments shall be made for which the Treasury may be liable; and

- (b) an account to be known as the Post Office Account into which shall be deposited —

- (i) all revenue received by the Directorate of Posts and Telecommunications;

- (ii) moneys received by that Directorate from any other source and which may be appropriated by a competent authority in the territory;

- (iii) all other moneys whatever received or held by that Directorate,

and from which all expenditure shall be defrayed and all payments shall be made for which the Directorate of Posts and Telecommunications may be liable.

BYLAE

Wysiging van artikel 1 van Wet 66 van 1975, soos gewysig deur artikel 6 van Proklamasie 85 van 1979

1. Artikel 1 van die Skatkis- en Ouditwet, 1975 (hieronder die Wet genoem), word hierby gewysig —

"Sentrale Inkomsterekening en Poskantoorrekening by Bank.

2. (1) Daar word by die Bank gehou —

- (a) 'n rekening met die naam die Sentrale Inkomsterekening waarin alle Staatsgeld, behalwe inkomste in paragraaf (b) bedoel, gestort word, en waaruit alle uitgawes bestry en alle betalings gedoen word waarvoor die Tesourie aanspreeklik is; en

- (b) 'n rekening met die naam die Poskantoorrekening waarin gestort word —

- (i) alle inkomste wat deur die Direktooraat van Pos- en Telekommunikasiewese ontvang word;

- (ii) gelde wat daardie Direktooraat uit enige ander bron ontvang en waaroor 'n bevoegde gesag in die gebied bewilligingsbevoegdheid besit;

- (iii) alle ander gelde hoegenaamd wat deur daardie Direktooraat ontvang of gehou word,

en waaruit alle uitgawes bestry en alle betalings gedoen word waarvoor die Direktooraat van Pos- en Telekommunikasiewese aanspreeklik is.

(2) The Directorate of Posts and Telecommunications may, for the purposes of defraying expenditure or of making payments for which it may be liable, utilize or retain on hand for utilization any moneys received without depositing such moneys in the account referred to in subsection (1)(b).

(3) (a) The Secretary for Inland Revenue shall cause the revenue of his department received from time to time, less the amount of any drawbacks or refunds, to be deposited in the Central Revenue Account referred to in subsection (1)(a).

(b) Such deposits shall be made on each appropriate working day.

(c) Returns of all such deposits shall on each appropriate working day be rendered by the Bank to the Treasury in such form as the Treasury may determine.

(4) Subject to any provisions of this Act or any other law to the contrary, no money shall be withdrawn from the accounts referred to in subsection (1) or utilized in terms of subsection (2) for the defrayal of expenditure chargeable to the Central Revenue Fund, unless the defrayal in question is in accordance with appropriation by law."

3. Section 3 of the Act is hereby repealed.

13. (1) There shall be kept proper account of all transactions in relation to the accounts referred to in section 2(1) —

- (a) in the case of transactions in relation to the Central Revenue Account, by the Treasury; and
- (b) in the case of transactions in relation to the Post Office Account, by the Directorate of Posts and Telecommunications,

by means of systems of account-books, accounts and records approved by the Treasury after consultation with the Auditor-General.

(2) As soon as practicable after the accounts in respect of any financial year have been closed, but in any case within six months after the close of the financial year —

- (a) the Treasury shall prepare statements of —
 - (i) the Central Revenue Fund;
 - (ii) the State debt of the territory and the amount of debt created and redeemed during the financial year;

 - (v) such other statements as the Auditor-General may deem necessary or desirable;
 - (b) the Directorate of Posts and Telecommunications shall prepare the following statements and accounts—
 - (i) a balance-sheet for the last day of the financial year and a revenue and expenditure account relating to the Post Office Savings Bank and National Savings Certificates referred to in sections 52 and 77A of the Post Office Act, 1958 (Act 44 of 1958), respectively;
 - (ii) such other statements and accounts as the Auditor-General may deem necessary or desirable.
 - (3) The Treasury shall within the period referred to in subsection (2), also prepare statements of the receipts under the various headings shown in the estimates of revenue on account of each of the votes shown in any appropriation Act for that year.
 - (4) (a) The Treasury, or as the case may be, the Directorate of Posts and Telecommunications shall transmit the statements and accounts referred to in subsections (2) and (3) to the Auditor-General for examination as soon as they have been prepared.
 - (b) The Directorate of Posts and Telecommunications shall transmit at the same time copies of the said statements and accounts to the Treasury.”.

- (a) National Savings Certificates issued by the Treasury in terms of section 77A of the Post Office Act, 1958, after the date of commencement of this Proclamation; and
- (b) the Post Office Savings Bank of South West Africa referred to in section 52 of the Post Office Act, 1958, as substituted by section 24 of this Proclamation:

Provided that any reference in those regulations —

- (i) to the Department of Posts and Telecommunications, shall be construed as a reference to the Directorate of Posts and Telecommunications;
- (ii) to the Postmaster-General, shall be construed as a reference to the person appointed as head of the Directorate of Posts and Telecommunications;

- (3) (a) The unexpended balance as at the date of commencement of this Proclamation of the amount of money appropriated for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending on 31 March 1980 by the Post Office Appropriation Proclamation, 1979 (Proclamation AG. 14 of 1979), shall be deemed to have been appropriated for the requirements of the Directorate of Posts and Telecommunications in respect of that financial year as a charge to the Central Revenue Fund on the vote of that Directorate in column 1 of the Schedule to the Appropriation Proclamation, 1979 (Proclamation AG. 12 of 1979).
- (b) For the purposes of section 14 of the Exchequer and Audit Act, 1975, the Directorate of Posts and Telecommunications shall specify on the receipts side of the appropriation account of the vote of that Directorate the amount of money appearing in the said Appropriation Proclamation, 1979, and any additional amount authorized by a competent authority in an additional Appropriation Act, while the amount actually expended since 1 April 1979 shall be specified on the expenditure side of that account.

39. This Proclamation shall be called the Exchequer and Audit Amendment Proclamation, 1979, and shall come into operation on 1 December 1979.
