APPLICATION THAT A PORTION OF FARM ROAD 440 BE CLOSED: DISTRICT OF BETHANIE

In terms of section 16(3) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that application has been made to the Chairperson of the Roads Board of Karas West that a portion of farm road 440 described in the Schedule and shown on sketch-map P2361 by the symbols A-B be closed.
