#### **APPLICATIONS FOR REGISTRATION OF TRADE MARKS IN NAMIBIA** (Applications accepted in terms of Act No. 48 of 1973)

Formal opposition should not be lodged until after notice has been given by letter to the applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failing such notice to the applicant an opponent may not succeed in obtaining an order for costs.


