**AMENDMENT OF REGULATIONS RELATING TO PARKS,
RECREATION GROUNDS AND CAMPING SITES**

The council of the Municipality of Windhoek has under section 242 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), further amended the Regulations relating to Parks, Recreation Grounds and Camping Sites promulgated by Government Notice 73 of 1977 as set out in the Schedule.

The said amendments have been approved by the President in terms of section 243 of the said Municipal Ordinance, 1963.

AMENDMENT OF MODEL HEALTH REGULATIONS

The council of the Municipality of Omaruru has under section 244(5) of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), further amended the Model Health Regulations promulgated under Government Notice 23 of 1955, and applied to the said Municipality by Government Notice 76 of 1956, as set out in the Schedule.

The said amendments have been approved by the President under section 243 of the said Municipal Ordinance, 1963.

SCHEDULE

The tariffs under the heading "Sanitation Fees" are hereby amended by the addition of the following item:

"Tariffs for use of Drains, Sewers and Sewerage Works.

3.1 *Basic Charge*

Every occupier of a lot, with or without improvements thereon, which is or can reasonably be connected to the council's sewerage system, shall annually pay to the council a basic charge calculated on 15c per m³ or part thereof of the total area of such lot.

3.2 *Additional Charge*

If a lot is connected to the council's sewerage system an amount of R8,00 per sanitary convenience shall be paid to the council for every sanitary convenience on such lot: Provided that a urinal longer than 70cm shall be divided by 70 and each 70cm of urinal or part thereof shall, for the purposes of this subitem, constitute a separate sanitary convenience.

3.3 For the purposes of this item a "lot" shall mean any erf, stand, premises, agricultural land or other area which forms a unit on its own."
