ELECTORAL ACT, 1992: ELECTION FOR LOCAL AUTHORITY COUNCIL OF AROAB: PUBLICATION OF LISTS OF CANDIDATES AND NOTIFICATION OF THE POLLING STATION

In terms of section 60(1) of the Electoral Act, 1992 (Act 24 of 1992), as applied by section 68(1) of that Act, and for the purposes of the election for members of the local authority council of Aroab to be held on 1 February
