GENERAL ELECTIONS FOR THE PRESIDENT AND MEMBERS OF THE NATIONAL ASSEMBLY:
DETERMINATION OF DAY AND PLACES FOR SUBMISSION OF NOMINATIONS OF CANDIDATES AND PARTY LISTS AND POLLING DAYS AND NOTIFICATION OF APPOINTED RETURNING OFFICERS

Under the powers vested in me by section 50(1) of the Electoral Act, 1992 (Act 24 of 1992), it is hereby made known that -

- (a) I have determined, in terms of that section -
 - (i) 7 November 1994 as -
 - (aa) the day on which a public sitting shall be held for the submission of nominations of candidates for election as President;
 - (bb) the last day on which a list of candidates shall be submitted for nomination of candidates for election as a member of the National Assembly;
 - (ii) that -
 - (aa) the said nominations shall be submitted to the Chairperson of the Electoral Commission at the High Court, Windhoek;
 - (bb) the said list of candidates shall be submitted to the Commission at the Directorate of Elections, Parsival Street, Windhoek;
 - (iii) 7 December and 8 December 1994 as the days upon which the poll of the election shall be taken;
- (b) the person whose name appears in the second column of the Schedule opposite the name of a constituency or polling station referred to in section 73(2A), has been appointed in terms of the provisions of section 51 of the said Act as returning officer at the election in that constituency or polling station.

AMENDMENT OF REGULATIONS FOR NOMINATION OF CANDIDATES FOR ELECTIONS

The Electoral Commission has, under section 130 of the Electoral Act, 1992 (Act 24 of 1992), made the regulations set out in the Schedule.

SCHEDULE

- 1. In this Schedule "the Regulations" means the regulations published by Government Notice 141 of 1992, as amended by Government Notice 149 of 1992.
- 2. The following heading is hereby substituted for the heading to the Regulations:
 - "REGULATIONS FOR NOMINATION OF CANDIDATES FOR ELECTIONS"
- 3. Regulation 4 is hereby amended by the substitution in subregulation (3) for the expression "section 60(1)", wherever it appears, of the expression "section 60(2)".
- 4. The following regulations are hereby inserted after regulation 4 of the Regulations:
 - "4A. (1) A person shall be nominated as a candidate for election to the office of President in writing on form ELECT 10(c).
 - (2) Any candidate for election to the office of President who consents to his or her nomination as required by section 55(2)(b) of the Act or who desires to withdraw such consent in terms of section 55(4)(b) of the Act, or a political party which, in terms of section 55(4)(a) of the Act, desires to withdraw its nomination of a candidate, may do so by completing the applicable section of Part D of form ELECT 10(c) and signing it.
 - (3) The list containing the names and other particulars of the persons supporting the nomination of an independent candidate in an election for the President referred to in section 55(2)(d) of the Act shall be annexed to form ELECT 10(c).
 - 4B. (1) The list of candidates nominated by a political party for the purposes of any election of members of the National Assembly in terms of section 59(1) of the Act, may be submitted on form ELECT 10(d).
 - (2) Any candidate who, in terms of section 60(2)(b) of the Act, desires to withdraw his or her candidature for any election of members of the National Assembly or a political party which, in terms of that section, desires to withdraw the candidature of a candidate nominated by it for such an election, may do so by completing, in the case of such candidate, Part A of form ELECT 11A, and, in the case of such political party, the applicable section of Part B of that form.
 - (3) A political party which, in terms of section 60(2) of the Act, desires to nominate an additional person or another person as a candidate in the place of a person whose candidature has been withdrawn by it, may do so by completing the applicable sections of form ELECT 12A.".
- 5. Regulation 5 is hereby repealed.
