REGULATIONS RELATING TO THE FEES PAYABLE BY AND TO THE BOARD UNDER THE PHARMACY ACT, 1993

The Minister of Health and Social Services has under section 51(i)(c) of the Pharmacy Act, 1993 (Act 23 of 1993) -

(a) made the regulations as set out in the Schedule; and

(b) repealed Government Notice No. R.349 (Republic) of 21 February 1975.

SCHEDULE

1. In these regulations, unless the context otherwise indicates, an expression in the Act has a corresponding meaning, and -

(2) The council may exempt a pharmacist from payment of any annual fee payable in terms of subregulation (1) on the grounds of age or of health or other such circumstances as the Board may approve.

(3) Any annual fee payable by a pharmacist in terms of subregulation (1)(e) and (x) upon initial registration as a pharmacist, shall be calculated on a *pro rata* basis from the first day of the month in which such registration took place until 31 December of the year of such registration.

(4) The following fee shall be paid by any person for the issue of a certificate of courses completed under the auspices of the Board: N\$ 150,00.

3. (1) The following fees and allowances shall be paid by the Board -

(a) person appointed to inspect a pharmacy:

N\$ 200,00;

- (b) person referred to in paragraph (a): travelling expenses as per Automobile Association fees for travelling to and from the pharmacy that is to be inspected;
- (c) member attending a meeting of the Board or of a committee of the Board or otherwise engaging in the business of the Board -
 - (i) fee payable per day, including travelling time to and from such a meeting or business of the Board;

N\$ 364,00;

- (ii) subsistence allowance per day, including the travelling time to and from such a meeting or business of the Board, if the duration of the meeting or business prevents him or her from returning to his place of residence on the same day, or if the member must spend the night prior to the meeting or business away from his or her place of residence:
- (iii) actual expenses in respect of subsistence, if he or she returns to his or her place of residence on the same day;
- (iv) (aa) his or her actual expenditure on the employment of a *locum tenens* during his or her absence from his or her retail pharmacy;
 - (bb) air, rail, bus or taxi fares; and
 - (cc) transport allowance as per Automobile Association Fees per kilometre if he or she uses his or her motor vehicle, in the absence of public transport.
 - (dd) a member who elects to travel by motor vehicle where air or rail services exists shall be refunded the appropriate air or rail fare.

(2) The fees and the subsistence allowance referred to in subregulation (1) shall be calculated as follows -

- (a) for the first day or part of a day, a full day's fees, payable to members and subsistence allowance, and thereafter for every 12 hours or part thereof, a half day's fees and subsistence allowance;
- (b) from the latest time that a member can reasonably be expected to leave his place of residence in order to attend a meeting until the earliest time that he can arrange to return to his place of residence -
 - (i) when the duration of a meeting is uncertain, a member shall be allowed a reasonable time after the conclusion of the meeting, but not exceeding 24 hours, for securing an air or train reservation for his return home;
 - (ii) the set fees shall not be paid in respect of a Sunday.
- (3) The following fees and allowances shall be paid by the Board -
- (a) to a member of a standing committee, subcommittee or *ad hoc* committee of the Board who is not a member of the Board or of a committee of the board: Fees and allowances equal to the fees and allowances referred to in subregulation (1)(c);
