PROCLAMATION OF A PORTION OF TRUNK ROAD 1/7 AND THE CLOSING OF A PORTION OF TRUNK ROAD 1/6: DISTRICT OF OKAHANDJA: OTJOZONDJUPA REGION

It is hereby made known -

ı,

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the district of Okahandja -
  - (i) under section 22(1)(b) of the said Ordinance declared the road described in Schedule I and shown on sketch-map P2002 by the symbols D-E to be a proclaimed road; and
  - (ii) under section 22(1)(c) of the said Ordinance closed a portion of trunk road 1/6 described in Schedule II and shown on sketch-map P2002 by the symbols A-B-C-D.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has under section 23(1)(b) of the said Ordinance declared the road referred to in paragraph a(i) to be a trunk road 1/7.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

#### **SCHEDULE I**

From a point (D on sketch-map P2002) at the junction with trunk road 1/7 on the farm Okahandja Town and Town lands 277 generally westwards via Kusweg across the said farm and the farm Consolidated Okahandja Town and Town lands 277 to a point (E on sketch-map P2002) at the junction with trunk road 7/1 on the last-mentioned farm.

#### **SCHEDULE II**

From a point (A on sketch-map P2002) at the junction with trunk road 7/1 and 1/6 on the farm Consolidated Okahandja Town and Town lands 277 generally north-north-westwards across the said farm, Okahandja Town and Town lands 277 via Hoof Street to a point (B on sketch-map P2002) on the last-mentioned farm; thence generally westwards via Van Riebeeck Street across the last-mentioned farm to a point (C on sketch-map P2002) on the last-mentioned farm; thence generally north-north-westwards via Voortrekker Street across the last-mentioned farm to a point (D on sketch-map P2002) at the junction with trunk road 1/7.
