SCHEDULE

DESCRIPTION OF BOUNDARIES OF THE PUROS CONSERVANCY
SITUATED IN THE OPUWO DISTRICT, KUNENE REGION

The point of beginning is at point 1, which is situated on the Skeleton Coast National Park boundary at the co-ordinates set out below.

From the point of beginning in an easterly direction to point 2 before turning in a north-east direction to point 3; from this point it once again follows an easterly direction to point 4, from whence it turns to the south-east through points 5, 6, 7, 8, 9, 10, 11 and 12; from this point in a southerly direction to point 13, whence it turns to the south-west until point 14 is reached; from this point it follows a north westerly direction to point 15, thence south to point 16, after which it follows a south westerly direction, until it intersects the eastern boundary of the Skeleton Coast National Park; from this point in a north westerly direction following the Skeleton Coast National Park boundary to the point of beginning.
