#### SEA FISHERIES ACT, 1992 DETERMINATION OF TOTAL ALLOWABLE CATCH IN RESPECT OF ROCK LOBSTER

Under section 15 of the Sea Fisheries Act, 1992 (Act No. 29 of 1992), and after consultation with the Sea Fisheries Advisory Council, I hereby determine that the Total Allowable Catch in respect of rock lobster for the allocation of quotas during the 2000 / 2001 rock lobster season commencing on 1 November 2000 and ending on 30 April 2001, shall be 350 metric tons. The said 350 metric tons shall be allocated in relation to each area mentioned in the first column of the table set out below, for the purpose of allocating quotas in respect of the period specified opposite such area in the second column of that table, be apportioned as specified opposite such area in the third column of that table:
