#### ELECTORAL ACT, 1992: ELECTION FOR THE REHOBOTH LOCAL AUTHORITY AREA IN THE HARDAP REGION: PUBLICATION OF CANDIDATES, POLLING DAYS AND POLLING STATIONS

#### ELECTORAL ACT, 1992: NOTIFICATION OF RESULTS OF THE BY-ELECTION OF THE KAPAKO CONSTITUENCY IN THE KAVANGO REGION

In terms of section 92(1) of the Electoral Act, 1992 (Act No. 24 of 1992), it is made known that a written statement in terms of section 90(3) was received from the returning officer in respect of the result of the by-election for the Kapako Constituency in the Kavango Region held on 17 May 2001 and that the particulars of that result are published in the Schedule as follows:

- (a) in Column 1 of the Schedule, the total number of votes counted in the Constituency and the total number of rejected ballot papers shown in brackets;
- (b) in Column 2 of the Schedule, the name of each candidate and the political party by which the candidate was nominated, with the name of the candidate who has been declared duly elected as a member of the Regional Council for the Kavango Region with effect from 18 May 2001 underlined;
- (c) in Column 3 of the Schedule, the number of votes recorded for each candidate.
