DETERMINATION OF PERIOD FOR SUPPLEMENTARY REGISTRATION OF VOTERS: KARIBIB CONSTITUENCY, ERONGO REGION AND OSHIKANGO CONSTITUENCY, OHANGWENA REGION: ELECTORAL ACT, 1992

Under the powers vested in me by section 15 of the Electoral Act, 1992 (Act No. 24 of 1992), I determine that a supplementary registration of voters shall take place during the period 21 November 2001 to 24 November 2001 in respect of the Karibib Constituency, Erongo Region and Oshikango Constituency, Ohangwena Region.

BY-ELECTION FOR A REGIONAL COUNCIL MEMBER IN KARIBIB CONSTITUENCY, ERONGO REGION AND IN OSHIKANGO CONSTITUENCY, OHANGWENA REGION: DETERMINATION OF DAY AND PLACE FOR SUBMISSION OF NOMINATIONS OF CANDIDATES AND POLLING DAY: ELECTORAL ACT, 1992

Under the powers vested in me by sub-section (1) of section 50 of the Electoral Act, 1992 (Act No. 24 of 1992), I make known that under paragraph (a) of that subsection in respect of the Karibib Constituency, Erongo Region and Oshikango Constituency, Ohangwena Region I have determined -

- (a) Wednesday, 14 November 2001, as the day on which public sittings shall be held for the submission of nominations of candidates for election as member of the regional council in respect of each of those Constituencies, and that the sittings shall be held from 09h00 until 11h00 at the Magistrate's office, Karibib and St. Mary Mission, Odibo, Oshikango, respectively; and
- (b) that, if a poll becomes necessary in any of those Constituencies for the reason that more than one person shall have been duly nominated at the close of the public sitting referred to in paragraph (a), the poll shall be taken on 19 December 2001, from 07h00 until 21h00.
