#### ROAD TRAFFIC AND TRANSPORT ACT, 1999

The Minister of Works, Transport and Communication has, -

- (a) in terms of section 26(2) of the Road Traffic and Transport Act, 1999 (Act No. 22 of 1999), withdrawn the function of testing persons for the issue of driving licences and learner's licences in terms of the Road Traffic and Transport Act, 1999, from the Namibian Police Force for the areas of the local authorities of Keetmanshoop, Mariental, Walvis Bay, Otjiwarongo, Tsumeb and Swakopmund with effect from 5 November 2001; and
- (b) in terms of regulation 102 of the Road Traffic and Transport Regulations, 2001, determined 5 November 2001 as the date from which every person or authority who the Minister intends to appoint in terms of section 27 of the Road Traffic and Transport Act, 1999, must apply for registration in terms of Part 1 of Chapter 4 of the Regulations.

#### ROAD TRAFFIC AND TRANSPORT ACT, 1999

The Minister of Works, Transport and Communication has, -

- (a) in terms of section 53(2) of the Road Traffic and Transport Act, 1999 (Act No. 22 of 1999), withdrawn the function of examining the roadworthiness of vehicles for the purposes of the Road Traffic and Transport Act, 1999, from the Namibian Police Force for the areas of the local authorities of Keetmanshoop, Mariental, Walvis Bay, Otjiwarongo, Tsumeb and Swakopmund with effect from 5 November 2001; and
- (b) in terms of regulation 144 of the Road Traffic and Transport Regulations, 2001, determined 5 November 2001 as the date from which every person or authority who the Minister intends to appoint in terms of section 54 of the Road Traffic and Transport Act, 1999, must apply for registration in terms of Part 1 of Chapter 5 of the Regulations.
