**SCHEDULE**

1. In this notice, unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the Karakul Pelts and Wool Act (Act No. 14 of 1982), bears that meaning.

2. (a) A special levy of three percent of the purchase price is payable by the seller to the agent, wool dealer or processor concerned, where such sale takes place -

- (i) by way of an auction; or
- (ii) by means other than by way of an auction,

whether within Namibia or outside of Namibia.

(b) For the purposes of subparagraph (a) above, the value of the special levy payable may be paid to that agent, wool dealer or processor by setting-off the value of the special levy from the purchase price of the wool concerned.

3. The special levy payable in terms of paragraph 2 is imposed for the defraying of expenditure incurred by the Board or agent of the Board in the implementing and carrying out of karakul wool related projects and for the selling and promotion of karakul wool within Namibia or elsewhere.

4. For purposes of this Schedule, the levy referred to in paragraph 2 above, must be paid over by the agent, wool dealer or processor to the Board within a period of three months from the date of purchase of the wool concerned.
