#### MAXIMUM DEPOSITS AND MAXIMUM REFUNDS ON RETURNABLE CONTAINERS: PRICE CONTROL ACT, 1964 (ACT NO. 25 OF 1964)

Under the powers vested in me under section 5 of the Price Control Act, 1964 (Act No. 25 of 1964), I -

- (a) repeal Government Notice No. 96 of 1991, published on 15 August 1991; and
- (b) prescribe -
  - (i) the maximum amount of a deposit required in respect of a returnable container mentioned in column 2 of the Schedule, in which goods mentioned in column 1 of the Schedule are sold, to be the amount mentioned in column 3 of the Schedule; and
  - (ii) that a seller of goods mentioned in column 1 of the Schedule must refund the amount mentioned in column 3 of the Schedule to a person who returns to that seller, in an undamaged state, a returnable container mentioned in column 2 of the Schedule.

#### EXEMPTION FROM THE PROVISIONS OF SECTION 92(1)(c) OF THE ROAD TRAFFIC AND TRANSPORT ACT AND REGULATIONS 336, 337 AND 338 OF THE REGULATIONS PROMULGATED BY GOVERNMENT NOTICE NO. 53 OF 30 MARCH 2001: THE ROAD TRAFFIC AND TRANSPORT ACT, 1999

Under section 105 of the Road Traffic and Transport Act, 1999 (Act No. 22 of 1999), I -

- (b) Repeal Government Notice No. 78 of 15 July 1991.
