#### CHANGE OF BOUNDARIES OF OMAHEKE AND KHOMAS REGIONS AND RE-DIVISION OF CERTAIN REGIONS INTO CONSTITUENCIES: REGIONAL COUNCILS ACT, 1992

In terms of section 5(3) of the Regional Councils Act, 1992 (Act No. 22 of 1992) and pursuant to the report of the Third Delimitation Commission, dated 13 November 2002, that has been accepted by me, I hereby -

(a) make known that -

- (i) the boundaries of the Omaheke and Khomas Regions have been changed and that the definition of the new boundaries of those regions are as set out in the amendments effected to the First Schedule to Proclamation No. 6 of 3 March 1992 (as amended by the Regional Councils Act, 1992 and by Proclamation No. 20 of 10 July 1992 and Proclamation No. 15 of 31 August 1998) by Schedule I to this Proclamation; and
- (ii) a re-division of the Omusati, Oshana, Ohangwena, Oshikoto, Kavango, Caprivi, Otjozondjupa, Omaheke and Khomas Regions into constituencies have been made and the boundaries and names of the constituencies concerned are as set out in the amendments effected to the Schedule to

Proclamation No. 25 of 1 September 1992 (as amended by Proclamations Nos. 42 of 22 October 1992, 16 of 31 August 1998 and 35 of 22 November 1999) by Schedule II to this Proclamation; and

- (b) substitute in Schedule III to this Proclamation, Schedules 1 and 2 to the Regional Councils Act, 1992, so as to bring those Schedules in line with the changes effected by this Proclamation and previous Proclamations issued under section 5(3) of the said Act and to correctly reflect the current state of affairs.

### **SCHEDULE I**

The First Schedule to Proclamation No. 6 of 3 March 1992 is amended as follows:-

1. The item "REGION NO. 10: OMAHEKE REGION" is amended by the substitution for paragraph (a) of the following paragraph:

"(a) The district of Gobabis as defined in Government Notice No. 313 of 27 February 1976 and includes the farms Omitara West 203 and Geiersberg 201;"

2. The item "REGION NO. 11: KHOMAS REGION" is amended by the substitution for paragraph (a) of the following paragraph:

"(a) The district of Windhoek, as defined in Schedule I to Government Notice No. 1148 of 30 June 1972, before the amendment of the boundaries of the said district by Government Notice No. 22 of 28 February 1989, but excluding the farms Omitara West 203 and Geiersberg 201;"

### **SCHEDULE II**

The Schedule to Proclamation No. 25 of 1 September 1992 is amended as follows:-

1. The item "REGION NO. 2: OMUSATI REGION" is amended -

- (a) by the substitution for the paragraph "*Elim Constituency*" of the following paragraph:

*"Elim Constituency*

Beginning at the point with co-ordinates latitude 17° 45' 14" south and longitude 15° 35' 15" east; thence southwards in a straight line to the point with co-ordinates latitude 17° 58' 48" south and longitude 15° 20' 10" east, so as to include the following villages: Uukwaandudhi, Ongolo, Olupembana, Ondangwa, Ekanda, Oshipoteka, Ontanga, Omundyalala, Amadhala and Alusati in the Constituency, and to exclude Okakola, Oshipya, Ekamba, Onenongo, Onekwaya, Olukonda, Omanyose, Etope and Iipopo Ya Ngolo villages from the Constituency; thence in a general north-westerly direction along the boundaries of the following villages: Okathitu B, Okathitu A, Oshilemba, Iihamayongwe and Iikango Ya Namwandi, so as to exclude these villages from the Constituency, to the point of intersection with the Okahao-Oshakati tarred road with co-ordinates latitude 17° 50' 33" south

and longitude 15° 15' 16" east; thence north-eastwards along the middle of that tarred road to the point with co-ordinates latitude 17° 47' 06" south and longitude 15° 21' 31" east; thence north-eastwards along the boundaries of the following villages: Oshuuli, Okalindi, Oongo and Iino to the point with co-ordinates latitude 17° 44' 28" south and longitude 15° 27' 40" east, so as to include Egululyeengumba, Okapumbu, Iikologo 1, Iikologo 2, Okapuku villages in the Constituency and to exclude Omuthitugwalani, Olutsiidhi, Iitananga, Ondjindja, Oshuuli, Okalindi and Oongo Villages from the Constituency; thence northwards in a straight line to the point with co-ordinates latitudes 17° 42' 52" south and longitude 15° 27' 41" east; thence eastwards in a straight line crossing the gravel road Elim-Oshikuku to the point with co-ordinates latitude 17° 42' 51" south and longitude 15° 29' 26" east; thence northwards to the point with co-ordinates latitude 17° 41' 27" south and longitude 15° 29' 07" east, so as to include Onashiku village in the Constituency and to exclude Iiyale and Iithindi villages from the Constituency; thence north-eastwards in a straight line to the point with co-ordinates latitude 17° 40' 08" south and longitude 15° 30' 26" east; thence south-eastwards along the middle of the trunk road Oshakati-Ruacana, so as to include Ipumbu, Oshuungu, Omwelwa, Uukwaandudhi villages in the Constituency and to exclude Okaku C, Oshuungu, Okapumbu, Onampila, Okaana and Okakola from the Constituency to the point of the beginning.";

- (b) by the substitution for the paragraph "*Okahao Constituency*" of the following paragraph:

*" Okahao Constituency*

Beginning at the point of the southern boundary of the Etosha National Park with co-ordinates latitude 19° 12' 22" south and longitude 15° 15' 57" east; thence in a general south-westerly direction along the fence of Etosha National Park to the point with co-ordinates latitude 19° 14' 48" south and longitude 14° 32' 11" east; thence southwards in a straight line along that fence to the point with co-ordinates latitude 19° 19' 44" south and longitude 14° 32' 19" east; thence eastwards in a straight line along the said fence to the point with co-ordinates latitude 19° 19' 36" south and longitude 14° 35' 39" east; thence generally southwards along the mentioned fence to the point with co-ordinates latitude 19° 25' 03" south and longitude 14° 35' 14" east; thence westward in a straight line to the point with co-ordinates latitude 19° 25' 03" south and longitude 14° 28' 29" east; thence in a general westerly direction to the point of intersection with Kamanjab-Opuwo gravel road with co-ordinates latitude 19° 24' 51" south and longitude 14° 26' 57" east; thence generally northwards, along the middle of that gravel road up to the point with co-ordinates latitudes 19° 01' 06" south and longitude 14° 21' 46" east; thence north-eastwards along the Etosha National Park fence up to the point with co-ordinates latitude 18° 49' 09" south and longitude 14° 39' 37" east; thence north-westwards along that fence to the point with co-ordinates latitude 18° 46' 11" south and longitude 14° 35' 54" east; thence north-westwards along the same fence up to the point with co-ordinates latitude 18° 38' 45" south and longitude 14° 34' 06" east; thence northwards in a straight line up to the point of intersection with a track with co-ordinates latitude 18° 12' 40" south and longitude 14° 33' 35" east; thence north-eastwards along the middle of that road up to the point with co-ordinates latitude 17° 59' 51" south and longitude 14° 59' 58" east; thence northwards in a straight line up to the point with co-ordinates latitude 17° 55' 03" south and longitude 14° 58' 57" east; thence north-eastwards in a straight line up to the point with co-ordinates latitude 17° 50' 59" south and longitude 15° 01' 49" east; thence eastwards along the existing Constituency boundary up to the point of intersection with the Oshana-Etaka and a track with co-ordinates latitude 17° 51' 04" south and longitude 15° 03' 59" east; thence eastwards along the middle of that Oshana up to the point with co-ordinate

latitude 17° 51' 14" south and longitude 15° 05' 19" east; thence south-eastwards along the middle of the said Oshana to the point of intersection with co-ordinates latitude 17° 53' 22" south and longitude 15° 08' 08" east, so as to include Uutota, Uukwanampanda and Ongozi villages in the Constituency and to exclude Okanya, Okaloko and Omuthitu Gwa Mwaala villages from the Constituency; thence north-eastwards along the middle of a track up to the point with co-ordinates latitude 17° 52' 25" south and longitude 15° 11' 07" east; thence south-eastwards along the middle of the Oshana up to the point with co-ordinates latitude 17° 54' 23" south and longitude 15° 12' 03" east, so as to exclude Epato-Olundjinda village from the Constituency; thence south-westwards along the middle of an Oshana to a point with co-ordinate latitude 17° 56' 11" south and longitude 15° 10' 58" east, so as to include Uukwamatsi village in the Constituency and to exclude Enongo villages from the Constituency; thence southwards along the middle of a track to the point with co-ordinates latitude 17° 56' 52" south and longitude 15° 10' 57" east, so as to include Uukwandongo No. 2 village in the Constituency and to exclude Oshikango village from the Constituency; thence south-eastwards along the middle of that track up to point with co-ordinates latitude 17° 57' 26" south and longitude 15° 11' 40" east; thence westwards along the middle of a track to the point of intersection with Etilyasa-Okahao road with co-ordinates latitude 17° 58' 13" south and longitude 15° 08' 22" east; thence south-eastwards along the middle of that road to the point with co-ordinates latitude 17° 58' 27" south and longitude 15° 08' 34" east; thence south-westwards along the middle of a track up to the point with co-ordinates latitude 17° 59' 12" south and longitude 15° 06' 51" east, so as to include Okashiya village in the Constituency; thence south-westwards and south-eastwards along the middle of a track up to the point with co-ordinates latitude 18° 02' 10" south and longitude 15° 06' 56" east, so as to include Onanghandja village in the Constituency and to exclude Etilyasa B village from the Constituency; thence south-eastwards along the middle of a track to the point with co-ordinates 18° 02' 27" south and longitude 15° 07' 20" east; thence southwards along the middle of a track up to the point where that track intersects the road with co-ordinates latitude 18° 07' 14" south and longitude 15° 07' 49" east; thence southwards along the middle of a road up to the point of intersection with co-ordinates latitude 18° 29' 11" south and longitude 15° 13' 17" east; thence southwards along a track to the point with co-ordinates latitude 18° 34' 09" south and longitude 15° 15' 27" east; thence in a general south-easterly direction along the western boundary of Ngandjera Pan to the point with co-ordinates latitude 18° 35' 10" south and longitude 15° 15' 58" east; thence southwards along the middle of a track up to the point of the beginning."; and

- (c) by the addition of the following paragraph:

*"Otamanzi Constituency*

Beginning at the point on the southern boundary of the Etosha National Park with co-ordinates latitude 19° 12' 22" south and longitude 15° 15' 57" east; thence northwards along the middle of a cut line to the point on the northern boundary of Etosha National Park with co-ordinates latitude 18° 36' 37" south and longitude 15° 15' 57" east; thence northwards in a straight line to the point on the Ngandjera Pan with co-ordinates latitude 18° 35' 11" south and longitude 15° 15' 58" east; thence westwards along the western side of Ngandjera pan north-westwards in the middle of the road to Amarika village, so as to include that village in the Constituency; thence in the general northwards along the middle of that road to the point of intersection with a track with co-ordinates latitude 18° 07' 15" south and longitude 15° 07' 51" east; thence north-westwards along the middle of a track passing between Onanyanga and Oshandumbala villages to the point with co-ordinates latitude 18° 02' 28" south and longitude 15° 07' 19" east; thence north-westwards

along a track to the point with co-ordinates latitude 18° 01' 39" south and longitude 15° 06' 30" east; thence in a general north-easterly direction along the track between Etilyasa B and Onanghandja villages to the point with co-ordinates latitude 17° 59' 07" south and longitude 15° 06' 54" east; thence north-eastwards along the middle of the road running along the southern boundary of the Okashiya village to the point in the middle of the gravel road coming from Etilyasa clinic with co-ordinates latitude 17° 58' 28" south and longitude 15° 08' 36" east so as to exclude that village from the Constituency; thence north-westwards along the middle of that gravel road to the point with co-ordinates latitude 17° 58' 13" south and longitude 15° 08' 22" east; thence north-eastwards along the middle of a track to the point with co-ordinates latitude 17° 57' 29" south and longitude 15° 11' 41" east; thence north-westwards along the western boundary of Oshikango village to the point in the middle of Oshana-Etaka with co-ordinates latitude 17° 56' 14" south and longitude 15° 10' 50" east, so as to exclude Uukwandongo No. 2 village from the Constituency; thence north-eastwards along the middle of that Oshana to the point of intersection with another Oshana with co-ordinates latitude 17° 54' 24" south and longitude 15° 12' 03" east; thence north-westwards along the middle of the last-mentioned Oshana to the point of intersection with the tarred road with co-ordinates latitude 17° 52' 25" south and longitude 15° 11' 08" east, so as to exclude Uukwamatsi and Etunda villages from the Constituency; thence in a general north-easterly direction along the middle of that tarred road to the point of intersection with a track with co-ordinates latitude 17° 50' 33" south and longitude 15° 15' 16" east, so as to exclude Okafitu-Kambwanda and Eengondo Mbali villages from the Constituency; thence generally south-eastwards along the middle of a track to the point with co-ordinates latitude 17° 53' 55" south and longitude 15° 16' 42" east so as to exclude Omuthitugwalani and Onawa villages from the Constituency; thence generally south-eastwards along the middle of a track to the point with co-ordinates latitude 17° 54' 09" south and longitude 15° 18' 23" east; thence in a general south-easterly direction to the point with co-ordinates latitude 17° 56' 39" south and longitude 15° 19' 08" east, so as to exclude Okadhiya Koshuumba and Onaanda villages from the Constituency; thence generally south-eastwards to the point with co-ordinates latitude 17° 56' 53" south and longitude 15° 20' 11" east; thence generally southwards to the point of intersection with cut line with co-ordinates latitude 17° 58' 49" south and longitude 15° 20' 10" east, so as to exclude Alusati village from the Constituency; thence south-westwards along the cut-line to the point of intersection with Oshana Etaka with co-ordinates latitude 18° 01' 59" south and longitude 15° 16' 42" east; thence in a general south-easterly direction along the middle of that Oshana to the point with co-ordinates latitude 18° 08' 48" south and longitude 15° 29' 56" east; thence south-eastwards in a straight line along the boundary between Engombe, Uuvudhiya and Efo-Etalala villages, to the point of intersection with the northern boundary of Etosha National Park with co-ordinates latitude 18° 39' 41" south and longitude 15° 34' 01" east; thence north-westwards, south-westwards along the northern boundary of Etosha National Park to the point with intersection with a track with co-ordinates latitude 18° 44' 25" south and longitude 15° 30' 09" east; thence south-eastwards in a straight line to the point with co-ordinates latitude 18° 53' 01" and longitude 15° 33' 49" east; thence southwards, south-westwards along the middle of a track from Narawandu village to the point of intersection with a gravel road with co-ordinates latitude 18° 58' 59" south and longitude 15° 30' 50" east; thence south-westwards along the middle of a track to the point with co-ordinates latitude 19° 04' 37" south and longitude 15° 19' 03" east; thence generally southwards along the middle of a track to the point with co-ordinates latitude 19° 09' 49" south and longitude 15° 19' 03" east; thence generally southwards along the middle of a track to the point of intersection with the southern boundary of Etosha National Park fence with co-ordinates latitude 19° 11' 29" south and longitude 15° 19' 01" east; thence south-westwards along that fence to the point of the beginning."

2. The item "REGION NO. 3: OSHANA REGION" is amended -

- (a) by the substitution for the paragraph "*Ongwediva Constituency*" of the following paragraph:

*"Ongwediva Constituency*

Beginning at the point on the existing regional boundary Oshana-Ohangwena with co-ordinates latitude 17° 41' 01" south and longitude 15° 52' 12" east; thence south-eastwards along the eastern boundary of Omatunda A village to the point with co-ordinates latitude 17° 41' 54" south and longitude 15° 52' 43" east; thence south-eastwards along the eastern boundary of Okadila village up to the point with co-ordinates latitude 17° 43' 03" south and longitude 15° 53' 48" east; thence southwards along the southern boundary of Okadila and Onamutayi villages up to the point on the existing constituency boundary in the middle of the gravel road Okapate Ka Ndola with co-ordinates latitude 17° 45' 01" south and longitude 15° 51' 46" east; thence south-eastwards along the middle of that gravel road so as to include Omatunda, Okadila and Onamutayi B villages in the Constituency; thence south-eastwards along the middle of the mentioned gravel road up to the point with co-ordinates latitude 17° 47' 45" south and longitude 15° 54' 29" east; thence south-westwards to the point of intersection with Gwalungalunga river with co-ordinates latitude 17° 47' 54" south and longitude 15° 54' 22" east; thence in a general south-westerly direction along the middle of that river to the point of intersection with the Ondangwa-Ongwediva trunk road with co-ordinates latitude 17° 50' 32" south and longitude 15° 53' 19" east, so as to exclude Okamutyasha, Okadhimeti, Ondangi and Okapya villages from the Constituency; thence in a general north-westerly direction along the middle of that road until it intersects the south-eastern corner beacon of the farm Ongwediva Town and Townlands 881; thence westwards and northwards along that farm boundary to the point with co-ordinates latitude 17° 45' 03" south and longitude 15° 44' 08" east; thence eastwards along the boundary of the mentioned farm until its intersection with the Oshana; thence from the middle of that Oshana in a general north-easterly direction until it meets the boundary common to the Oshana and Ohangwena Regions; thence eastwards along the regional boundary to the point of the beginning."; and

- (b) by the substitution for the paragraph "*Okaku Constituency*" of the following paragraph:

*"Okaku Constituency*

Beginning at the point in the middle of the gravel road Endola-Omwandi Wa Kamanya with co-ordinates latitude 17° 51' 37" south and longitude 15° 57' 49" east which is on the existing constituency boundary; thence westwards in a straight line to the point with co-ordinates latitude 17° 51' 39" south and longitude 15° 55' 56" east; thence southwards to the point of intersection with Ondangwa-Ongwediva tarred road with co-ordinates latitude 17° 52' 32" south and longitude 15° 55' 57" east; thence generally north-westwards along the middle of that tarred road to the point with co-ordinates latitude 17° 50' 32" south and longitude 15° 53' 19" east, which is an intersection between the said tarred road and the Gwalungalunga river; thence generally north-eastwards along the middle of the said river to the point with co-ordinates latitude 17° 47' 54" south and longitude 15° 54' 22" east; thence north-eastwards in a straight line to the point in the middle of a gravel road Okapate Kandola with co-ordinates latitude 17° 47' 45" south and longitude 15° 54' 29" east which is on the existing constituency boundary, so as to include the Okapya 1, Okapya 2, Ondangi, Okadhimeti, Okamutyasha villages in the Okaku Constituency; thence north-westwards

along the middle of the mentioned gravel road, on the existing constituency boundary to the point with co-ordinates latitude 17° 45' 01" south and longitude 15° 51' 46" east; thence north-eastwards along the southern boundaries of Onamutayi B and Okadila villages to the point with co-ordinates latitude 17° 43' 09" south and longitude 15° 53' 48" east; thence north-westwards along the eastern boundary of Okadila village to the point with co-ordinates latitude 17° 41' 54" south and longitude 15° 52' 43" east; thence north-westwards along the north-eastern boundary of Omatunda A village to the point with co-ordinates latitude 17° 41' 09" south and longitude 15° 52' 12" east; thence northwards to the point on the existing regional boundary between Ohangwena and Oshana Regions with co-ordinates latitude 17° 41' 01" south and longitude 15° 52' 12" east, so as to exclude Onamutayi B, Okadila, Omatunda A villages from the Okaku Constituency; thence in a general easterly direction in a straight line along the Oshana-Ohangwena regional boundary to the point with co-ordinates latitude 17° 41' 22" south and longitude 15° 59' 59" east; thence in a southerly direction in a straight line to the north-eastern corner beacon of the farm Ondangwa Townlands 882 with the co-ordinates latitude 17° 51' 35" south and longitude 15° 59' 57" east; thence westwards in a straight line to the point of the beginning."

3. The item "REGION NO. 4: OHANGWENA REGION" is amended -

- (a) by the substitution for the paragraph "*Oshikango Constituency*" of the following paragraph:

*"Oshikango Constituency*

Beginning at the point along the Namibia-Angola international boundary where it is intersected at the Oshikango border post by a trunk road B1; thence eastwards along the said border to a point where it is joined by a road from the south-west at approximate system 22/17 with co-ordinate Y+ 95500; thence along the middle of the last-mentioned road in a general south-westerly and southerly direction to the point with co-ordinate X- 497000; thence on a grid direction 90° to the point with co-ordinate Y+ 102500; thence on a grid direction 0° in a straight line to a point with co-ordinates latitude 17° 31' 13" south and longitude 16° 02' 04" east, which is in the middle of the tarred road Onhuno-Eenhana; thence south-westwards along the boundary of Outwilo village, thence south-eastwards along the middle of a track running between Enghandja, Outwilo, Etope and Oshimumu villages, so as to include the Enghandja village in the Constituency and to exclude all those three last mentioned villages from the Constituency, to the point with co-ordinates latitude 17° 34' 43" south and longitude 16° 01' 55" east; thence westwards and north-westwards along the boundary, between Enghandja and Oshatotwa villages so as to exclude Oshatotwa from the Constituency to the point with co-ordinates latitude 17° 33' 39" south and longitude 16° 00' 08" east; thence south-westwards in the middle of the trunk road to the point in the middle of Gwashigambo river with co-ordinates latitude 17° 33' 55" south and longitude 15° 59' 28" east in a general north-westerly direction along the middle of that river to the point with co-ordinates latitude 17° 31' 17" south and longitude 15° 58' 54" east; thence north-westwards in a straight line to the point in the middle of the trunk road B1 with co-ordinates latitude 17° 27' 21" south and longitude 15° 53' 33" east; thence northwards along the middle of that trunk road to the point of the beginning.";

- (b) by the substitution for the paragraph "*Ondobe Constituency*" of the following paragraph:

*"Ondobe Constituency"*

This Constituency comprises the Khomas Region as defined, but excluding the following constituencies: Samora Machel, Tobias Hainyeko, Moses //Garoeb, Katutura East, Katutura Central, Soweto, Khomasdal North, Windhoek West and Windhoek East.”.
