#### ANNOUNCEMENT OF PRESIDENTIAL PARDON OR REPRIEVE TO CERTAIN CATEGORIES OF PRISONERS

In terms of Article 32(8) of the Namibian Constitution, I announce that I have, under the powers vested in me by Article 32(3)(d) of the Constitution, on the occasion of the 13th anniversary of the independence of the Republic of Namibia on 21 March 2003, granted pardon or reprieve to certain prisoners as set out in paragraph 1 below, except any prisoners to whom the provisions of paragraph 2 apply:

1. (a) The following prisoners have been pardoned:
    - (i) Those serving sentences of imprisonment whose conditional release on parole has been approved before or on 21 March 2003;
    - (ii) Those serving sentences of imprisonment of 2 years or less and who on 21 March 2003 have served one half or more of their sentences;
    - (iii) Those of the age of 60 years or more;
    - (iv) Pregnant prisoners with 6 months or more pregnancy; and
    - (v) Juveniles.
  - (b) Pardon has also been granted to all prisoners who, on 21 March 2003, are serving sentences of 2 years or less but who on that date have not yet completed half of their sentences, which pardon is to become of effect on the date that they complete serving half of their sentences.
  - (c) Reprieve of a period of six months has been granted to prisoners who are serving sentences of more than two years but not more than three years and who on 21 March 2003 have served half or more of their sentences.
  - (d) Reprieve of a period of six months has also been granted to prisoners who are serving sentences of more than two years but not more than three years but who, on 21 March 2003, have not yet completed half of their sentences, which reprieve is to become of effect on the date they complete serving half of their sentences.
2. The pardon and reprieve granted under paragraph 1 do not apply to any prisoners contemplated in that paragraph who fall in any of the following categories:
    - (a) Prisoners who have been convicted of a minor or a major prison offence at any time during the period 21 September 2002 to 21 March 2003.
    - (b) Prisoners convicted of any of the following offences:
      - (i) Assault on a woman or child, when a dangerous wound was inflicted.
      - (ii) Rape.
      - (iii) Murder, when committed with violence.
      - (iv) Robbery with aggravating circumstances.

- (v) Housebreaking with aggravating circumstances.
- (vi) Treason.
- (c) Prisoners who had been released under previous Presidential pardons or reprieve since Namibia's date of independence and convicted again for crimes or offences committed thereafter.
- (d) Prisoners who, on 21 March 2003, have further charges pending.
- (e) Prisoners who previously were released on parole but violated the parole conditions by committing another offence while on parole.
- (f) Prisoners who escaped from prison and while at large committed an offence.
