PUBLICATION OF RESULT OF BY-ELECTION FOR GROOTFONTEIN CONSTITUENCY, OTJOZONDJUPA REGION: ELECTORAL ACT, 1992

In terms of section 92(1) of the Electoral Act, 1992 (Act No. 24 of 1992), the announcement made and transmitted to the Commission in terms of section 90(3) and the particulars contained in that announcement in respect of the result of the by-election for the Grootfontein Constituency, Otjozondjupa Region held on 12 February 2004 and set out in the Schedule, are published as follows -

- (a) in Column 1 of the Schedule, the total number of votes counted and the total number of rejected ballot papers shown in brackets;
- (b) in Column 2 of the Schedule, the name of each candidate and, opposite to the name, the political party by which the candidate was nominated, with the name of the candidate who has been declared duly elected as a member of the Otjozondjupa Regional Council with effect from 12 February 2004 underlined; and
