SPECIFICATION OF BUSINESSES AND CATEGORIES OF BUSINESSES PROVIDING SERVICES OR GOODS WHICH CAN BE PROVIDED ADEQUATELY BY NAMIBIANS: FOREIGN INVESTMENT ACT, 1990

Under section 3(4) of the Foreign Investment Act, 1990 (Act No. 27 of 1990), I specify the following businesses and categories of businesses as businesses and categories of businesses which, in my opinion, are engaged primarily in the provision of services or goods which can be provided adequately by Namibians -

- (a) retail businesses, unless a foreign national who intends setting up any form of retailing business of any size in Namibia, has first sought and obtained the permission of the Minister of Trade and Industry;
- (b) public transport services (taxi and shuttle services within and between towns); and
- (c) hair salon, hair dressing, and beauty treatment services.

With effect from the date of publication of this notice in the *Gazette*, no foreign national shall, subject to section 7(3) of that Act, through the investment of foreign assets, become engaged in or be permitted to become engaged in any business so specified or falling within the category of business so specified.

AMENDMENT OF REGULATIONS UNDER THE CASINOS AND GAMBLING HOUSES ACT, 1994

Under section 54 of the Casinos and Gambling Houses Act, 1994 (Act No. 32 of 1994), I make the regulations set out in the Schedule.

SCHEDULE

- 1. In this Schedule "the Regulations" means the regulations under the Casinos and Gambling Houses Act, 1994 (Act No. 32 of 1994) promulgated by Government Notice 231 of 2 December 1994, as amended by Government Notice 84 of 15 May 1995, Government Notice 136 of 11 August 1995 and Government Notice 121 of 27 May 1996.
- **2.** Regulation 23B is amended by the substitution for subparagraph (1) of the following subparagraph:

"Restriction on profit-sharing with respect to gambling machines

- 23B (1) Where the Minister has granted authority under section 38 of the Act allowing a person to share in the profits derived from any gambling house operations under a licence, it shall be a condition of such authority that no person to whom the authority relates, other than the holder of the licence, shall share in the profits so derived by more than 50 percent of those profits, but without prejudice to any agreement between the parties for a lesser ratio of distribution of such profits in favour of such other person."
- **3.** Regulation 23B is amended by the substitution of paragraph (2) of the following subregulation:
 - "(2) An authority granted under section 38 by the Minister-
 - (a) in respect of a gambling house shall be valid for a period of two years, but may from time to time, upon application made under that section by the parties concerned, be renewed by the Minister on recommendation from the Board, but not for a period of more than two years at any one time; and
 - (b) in respect of a casino shall be valid for a period of fifteen years, but may from time to time, upon application made under that section by the parties concerned, be renewed by the Minister on recommendation from the Board, but not for a period of more than fifteen years at any one time."

4. Conditions of title:

- (1) The following condition must be registered in favour of the Local Authority against the title deeds of all erven except the erven mentioned in paragraph 3.
- (a) The erf must be used or occupied for purposes which are in accordance with, and the use or occupation of the erf must at all times be subject to, the provisions of the Katima Mulilo Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance No. 18 of 1954), as amended.
- (b) The building value of the main building, including the outbuildings to be erected on the erf, must be at least four times the valuation of the erf by the Local Authority.
