NAMPOST TARIFF ADJUSTMENTS FOR 2012/2013

Namibia Post Limited wishes to inform you that its annual tariff adjustments will become effective on 1 October 2012, in line with the commencement of its new financial year.

During the previous years, NamPost committed itself to future increases that are broadly in line with inflation expectations (CPI) and the cost of doing business, generally, especially on business lines with international component. The latter specifically relates to mail to and from international destinations.
