NOTICE IN TERMS OF THE REGULATIONS REGARDING THE SUBMISSIONS OF INTERCONNECTION AGREEMENTS AND TARIFFS

The Communications Regulatory Authority of Namibia, in terms of regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs", in Government Gazette No. 4714, Notice No. 126, dated 18 May 2011, herewith gives notice that **Telecom Namibia Limited** has filed a tariff with the Authority as set out in Schedule 1.

Any person may examine copies of the tariffs submitted at the head offices of the Authority during normal business hours and copies may be made on payment of a fee determined by the Authority. Copies are also available at www.cran.na where copies may be downloaded free of charge.

The public may submit in writing to the Authority written comments within fourteen (14) days from the date of publication of this notice in the *Gazette*.

Telecom Namibia Limited may submit, in writing to the Authority, a response to any written comments within fourteen (14) days from the lapsing of the time to submit written submissions.

All written submissions must contain the name and contact details of the person making the written submissions and the name and contact details of the person for whom the written submissions is made, if different and be clear and concise.

Notes on costs of 2 Meg uplink/downlink:

Asymmetric:

With the Asymmetric service, the data speed or amount of transmitted data differs in one direction compared with the other direction. The system uses most of the channel to transmit downstream to the user and only a small part to receive information from the user. Meaning, down link and uplink speeds are for instance on a 1:2 or 1:3 ratios (Example 1024k downlink and 512k Uplink depending on how it is technically defined and provisioned)

Symmetric:

With the symmetric service, the data speed or amount of transmitted data is the same in both directions. The system uses the channel to transmit downstream to the user at the same rate or amount of transmitted data as to receiving information from the user. Uplink and downlink speeds are on a ratio of 1:1 (Example 1024k downlink and 1024k uplink).

General:

In the event of incorrect billing, customers are entitled to register dispute over the affected portion of the account by reporting through the Customer Care Centre's toll free number 1100 or the nearest Teleshop.

REASONS FOR THE DECISION ARE AS FOLLOWS:

Khorixas Youth and Community Media Centre submitted applications for a community broadcasting service license and spectrum use license on 12 June 2013 for consideration by the Authority, in accordance with sections 85 and 101 of the Communications Act, 2009 (Act No. 8 of 2009) and the Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting service Licenses and Spectrum Use Licenses as published in Government Gazette No. 4785, General Notice No. 272 of 29 August 2011.

As per the constitution submitted, Khorixas Youth and Community Media Centre is a community project, founded in 2012 to provide community broadcasting services in Khorixas and surrounding areas and intends to broadcast under the K-FM brand name. An application for funding and training of local Namibians was submitted to the United Nations Educational Scientific and Cultural Organisation (UNESCO) Windhoek office.

In terms of Section 101 (6) of the Communications Act, 2009 (Act No. 8 of 2009) a community broadcasting service license application must be accompanied by spectrum use license application if the applicant intends to use spectrum in the provision of the intended broadcasting service. Khorixas Youth and Community Media Centre submitted an application for spectrum use for FM broadcasting frequency between 87 MHx and 108 MHz dated 13 June 2013 in the geographical are of Khorixas and a transmitter output power of 600 Watt. Khorixas Youth and Community Media Centre intends to construct their own broadcasting transmitter tower and provide their own signal distribution service as required by regulation 5 (2) of the Regulations Regarding Licensing Procedure for Telecommunications and Broadcasting Service Licenses and Spectrum Use Licenses.

Khorixas Youth and Community Media Centre submitted a program schedule, constitution and certified copies of identity documents as required on the applications forms for service and spectrum use on 23 August 2013. The program schedule stipulates that FM radio services will be broadcasted from 06h00 to 22h00 from Monday to Sunday. The spectrum use application form stated that the broadcasting transmitted tower will be located at House No. D1, Khorixas.

An applicant for a community service licence is required to submit financial resources available as required by Regulation 5 (2)(k) of the Regulations Regarding Licenscing Procedure for Telecommunications and Broadcasting Service Licensces and Spectrum Use Licenses –

"include a statement of accounts setting out the financial resources available to the applicant in relation to the broadcasting service applied for;"

Khorixas Youth and Community Media Centre submitted the authorization letter to construct a broadcasting transmitter tower by Khorixas Town Council on 24 April 2014. UNESCO confirmed funding of the project as well as a detailed outline of implementation and training of staff and volunteers from the community directly to the Authority on 19 May 2014.

Following due process in terms of regulation 11 of the Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting Service Licenses and Spectrum use Licenses, the Authority published a notice in the Government Gazette 5374, Notice No. 520, dated 24 December 2013, allowing fourteen (14) days for public comments from the date of publication of the Notice in the *Gazette*. The comments period closed on the 6th of January 2014 and no comments were received and subsequently no reply comments were requested from Khorixas Youth and Community Media Centre. The last day for a decision is the 18th of July 2014.

The Kunene region is home to an estimated population of 68,735 as reflected in the Namibia 2011 Population and Housing Census Main Report (Namibian Statistics Agency, 2013). Khorixas is surrounded by approximately 50 villages and has limited access to information and broadcasting services.

FM broadcasting services is limited to NBC services transmitting from Renosterkop in Afrikaans, Damara/Nama and Herero as well as NBC National Radio. The Authority notes that no community broadcaster is offering FM radio services to this area to date.

Khorixas Youth and Community Media Centre envisages the training of 10 people with the assistance of UNESCO to manage a community broadcasting station, programme production and technical expertise. Programs will contain local content, national news, Khorixas police reports and sport updates and will be transmitted in local languages.

In the opinion of the Authority the funding provided by UNESCO is sufficient to maintain a community radio broadcaster. Furthermore UNESCO will provide training to equip Namibians to manage and operate all broadcasting service. The establishment of this project will assist in the upliftment of the community of Khorixas and provide access to information as well as entertainment.

The application submitted complies with all technical requirements contained in Section G of the spectrum use license application form in that equipment specification, coverage plots, antennae heights and site coordinates have been submitted to the Authority. The Khorixas Town council has also granted approval for the construction of a broadcasting transmitter tower. Due to the lack of broadcasting services in this area there is no shortage of available spectrum. Khorixas Youth and Community Media Centre is 100% Namibian owned and thus fully compliant with section 85(2) of the Communications Act, 2009.

The Authority notes that the applicant requested a power output of 600W. As the broadcasting transmitter tower will be located within Khorixas itself, the Authority recommends a power output of 250W. This recommended power output will be sufficient to provide broadcasting services to Khorixas and surrounding areas. The Authority has also considered that the applicant is a community broadcaster and implementation of a lower output whilst still providing the envisaged broadcasting coverage area will put less strain on the financial resources of the applicant as lower spectrum fees will be levied.

In light of the above, the Authority approved the issuance of a Community Broadcasting Service License to Khorixas Youth and Community Media Centre as well as a spectrum use license for 105.8 MHz with a power output of 250W in the geographical are of Khorixas, in terms of section 85 (1) and 101 of the Communications Act.

The service license is awarded subject to the Communications Act, 2009 (Act No. 8 of 2009) and the Regulations regarding License conditions for Broadcasting Service Licenses as published in Government Gazette No. 5037, Notice No. 309 dated 13 September.

And the Spectrum uses licenses is awarded subject to the Communications Act, 2009 (Act No. 8 of 2009) and the Regulations regarding License Conditions for Spectrum Use Licensee as published in Government Gazette No. 5354, Notice No. 469, dated 2 December 2013.

REASONS FOR APPROVAL OF TARIFFS

MWireless (Pty) Ltd t/a Africa Online (hereinafter referred to as "Africa Online"), filed for the approval of tariffs for new NAWASAT (VSAT) Products on 12 May 2014 in terms of section 53 (1) and (7) of the Communications Act, 2009 (Act No. 8 of 2009) (hereinafter referred to as "the Act"). The submission was made to obtain approval in terms of section 53(1) and (7).

The proposed tariffs were published as General Notice No. 128 in the Government Gazette No. 5479 dated 10 June 2014 for public comments in terms of section 53 (10) of the Act and regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs" published in Government Gazette No. 4714 of 18 May 2011.

Comments were invited from the public, in terms of the Notice published in the *Gazette*, within a period of fourteen (14) days from the date of publication, which period lapsed on 24th June 2014. No public comments were received in respect of the tariffs, and as such, no reply comments were required from Africa Online.

Africa Online submitted the new tariffs in terms of section 53(1) and (7) of the Act, which stipulates that all rates and charges received in respect of any telecommunications services must be in accordance with a tariff filed and permitted to come into operation in accordance with the provisions of section 53 and it should be filed in the prescribed manner with the Authority for approval.

The tariff packages submitted are new packages to supplement the current NAWASAT packages approved by the Authority on 8 August 2013 and published in Government Gazette No. 5460 dated 8

May 2014. The tariffs are an extension of the current NAWASAT products and is developed to benefit homes, schools and businesses that do not have easy access to Internet in very remote areas where there is limited infrastructure.

The previous NAWASAT products, as approved by the Authority, were only up to a download speed of 6144k and capped at 10GB. Some higher upload speeds were also added. The current products are more designed for larger users such as businesses and download speeds are up to 8192k and capped at 71GB.

All requirements in terms of section 53 of the Act that deals with the approval of tariffs have been adhered to as follows:

- 1. The tariffs were published as stipulated in section 53(10) for comment and Africa Online stated that the tariff would come into force on 13 July 2014 as required by section 53(8) of the Act that stipulates that the Licensee has to indicate the date that the tariffs will come into force.
- 2. All pertinent information as required by section 53(9) was submitted to the Authority such as the terms and conditions, which include rights and remedies available to the consumer in the event of disputes.
- 3. The tariffs contained the cost information as required by section 53(18) of the Act.

The tariffs submitted would give customers more choice since more products at more speeds and different tariffs were added which are designed for customers in rural areas. Therefore, the tariffs are reasonable, are not deemed discriminatory or impairing competition.

In light of the above, and in terms of section 53 of the Act, the Board approved the NAWASAT (VSAT) tariffs as submitted by Africa Online.

REASONS FOR APPROVAL OF TARIFFS

Telecom Namibia Limited (hereinafter referred to as "Telecom Namibia"), filed for the approval of tariffs for MaxiPlus and Maxi Packages on 15 May 2014 in terms of section 53 (1) and (7) of the Communications Act, 2009 (Act No. 8 of 2009) (hereinafter referred to as "the Act"). The submission was made to implement the new pricing as promotional pricing in terms of section 53(2) of the Act and obtain approval in terms of section 53(1) and (7).

The proposed tariffs were published as General Notice No. 128 in the Government Gazette No. 5479 dated 10 June 2014 for public comments in terms of section 53 (10) of the Act and regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs" published in Government Gazette No. 4714 of 18 May 2011. The date of the request was 15 May 2014 and the promotion started on 16 May 2014. The promotion will thus end on 15 August 2014.

Comments were invited from the public, in terms of the Notice published in the Government Gazette, within a period of fourteen (14) days from the date of, which period lapsed on 24 June 2014. No public comments were received in respect of the tariffs, and as such no reply comments were required from Telecom Namibia.

Telecom Namibia submitted the new tariffs in terms of section 53(1) and (7) of the Act, which stipulates that all rates and charges received in respect of any telecommunications services must be in

accordance with a tariff filed and permitted to come into operation in accordance with the provisions of section 53 and it should be filed in the prescribed manner with the Authority for approval.

This is a new product that Telecom Namibia is launching which is a combination of fixed and mobile services. TN1 MaxiPlus Package is a combination of fixed and mobile voice and fixed and mobile data. The TN Maxi Package is a combination of fixed and mobile data.

The charges are as follows when compared with current charges:

The tariff packages submitted are new packages with new tariffs as mentioned hereinabove. These tariffs are competitive with the SmartShare packages approved for Mobile Telecommunications Limited (MTC) as published in Government Gazette No. 5231 dated 24 June 2013 which is a combination of mobile data and voice on different devices. A comparison of the current charges in the market was done since it is very difficult to compare the packages. There are too many differences between the package proposed by Telecom Namibia and the SmartShare package of MTC e.g. the MTC package deals only with mobile devices whereas the Telecom Namibia package combines mobile and fixed line devices.

From the out-of-bundle charges that Telecom Namibia is proposing the voice tariff is comparing to the fixed voice tariff approved on the CallMaker Packages. The SMS rate is as approved for the TN Mobile Packages and the data rate is lower than the currently approved TN Mobile data rate.

All requirements in terms of section 53 of the Act that deals with the approval of tariffs have been adhered to as follows:

- 1. The tariffs were published as stipulated in section 53(10) for comment and Telecom Namibia stated that the tariff would come into force once the Authority approved the tariff as required by section 53(8) of the Act that the Licensee has to indicate the date that the tariffs will come into force.
- 2. All pertinent information as required by section 53(9) was submitted to the Authority such as the terms and conditions, which includes rights and remedies available to customers in the event of disputes.
- 3. The tariffs contained the costing information as required by section 53(18) of the Act.

The tariffs will benefit customers since it is a reduction from previously approved tariffs. It further gives the customer more choice. As such the tariffs are reasonable, are not deemed discriminatory or impairing competition.

In light of the above, and in terms of section 53 of the Act, the Board approved the Telecom Namibia TN Maxi Tariff Packages as submitted.

- 3. CPE is excluded and will be charged for separately (customers will have the option to rent or purchase the CPE of their choice).

General

In the event of incorrect billing, customers are entitled to register dispute over the affected portion of the account by reporting through the Customer Care Centre's toll free number 1100 or the nearest Teleshop.

REASONS FOR APPROVAL OF TARIFFS

Telecom Namibia Limited (hereinafter referred to as "Telecom Namibia"), filed for the approval of the amendment of tariffs for Speedlink Data Only Packages on 19 March 2014 in terms of section 53 (1) and (7) of the Communications Act, 2009 (Act No. 8 of 2009) (hereinafter referred to as "the Act"). The submission was made to implement the new pricing as promotional pricing in terms of section 53(2) of the Act and obtain approval in terms of section 53(1) and (7).

The proposed tariffs were published as General Notice No. 128 in the Government Gazette No. 5470 dated 27 May 2014 in terms of Regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs" published in Government Gazette No. 4714 of 18 May 2011. The date of the request was 19 March 2014 and the promotion started on 20 March 2014. The promotion will thus end on 20 June 2014.

Comments were invited from the public, in terms of the Notice published in the *Gazette*, within a period of fourteen (14) days from the date of publication of the Notice in the *Gazette*, which period lapsed on 11 June 2014. No public comments were received in respect of the tariffs, and as such no reply comments were required from Telecom Namibia.

When compared to the previous approved tariffs for Telecom Namibia Speedlink these tariffs show a significant reduction.

All requirements in terms of section 53 of the Act that deals with the approval of tariffs have been adhered to as follows:

1. The tariffs were published as stipulated in section 53(10) for comment and Telecom Namibia stated that the tariff would come into force once the Authority approved the tariff as required by section 53(8) of the Act that the Licensee has to indicate the date that the tariffs will come into force.

- 2. All pertinent information as required by section 53(9) was submitted to the Authority such as the terms and conditions, which includes rights and remedies available to customers in the event of disputes.
- 3. The tariffs contained the costing information as required by section 53(18) of the Act.

The tariffs proposed are significant lower than the previously approved tariffs for Speedlink with reductions between 39% and 71%. This reduction will be good for both household and business customers alike since data tariffs in Namibia are still high. At the same time this reduction will make these services more affordable and accessible to more customers.

The Speedlink Professional Tariffs only differ from the Speedlink Data only (Home and Business) in the sense that to qualify for these tariffs you require a static Internet Protocol (IP) address. This means higher speeds due to dedicated lines and will be mostly utilized by businesses.

The tariffs will benefit customers since it is a reduction from previous tariffs. The tariffs are reasonable, are not deemed discriminatory or impairing competition.

In light of the above and in terms of section 53 of the Act, the Board approved the Speedlink Data only tariffs as submitted by Telecom Namibia.
