NOTIFICATION FOR INSPECTION OF PROVISIONAL VALUATION ROLL AND COMMENCEMENT OF SITTING OF VALUATION COURT: AGRICULTURAL (COMMERCIAL) LAND REFORM ACT, 1995

In terms of regulation 6(4) of the Land Valuation and Taxation Regulations published under Government Notice No. 120 of 3 July 2007, I -

- (a) give notice that the provisional valuation roll and the iso-value map lie open for inspection during office hours at the places set out in Column 1 and located in the location specified in Column 2 of Schedule 1 from 1 June 2016 to 1 July 2016;
- (b) give notice that the valuation court commences its sitting at 10h00 on 1 August 2016 at the places indicated in Schedule 2 to consider any valuation contained in such provisional valuation roll and to hear every objection lodged in respect of any such valuation;
- subject to a payment of N\$6 per page, invite any interested person who wishes to get a copy of the provisional valuation roll or any part of the provisional valuation roll to do so during the period specified in paragraph (d);

- (d) call upon every owner of agricultural land in respect of which a valuation is contained in the provisional valuation roll who wishes to object to the valuation, to lodge, within 30 days of the date of publication of this notice an objection, on Form 1 contained in the Annexure of the said regulations, against the valuation setting out the grounds on which the objection is based; and
- (e) call upon every owner of the agricultural land in respect of which such land is contained or omitted on the provisional valuation roll who wishes to correct such information, to lodge, within 30 days of the publication of this notice, a data correction request to be made on Form 3 contained on the Annexure of the said regulations.
