DECLARATION OF BRAKWATER INDUSTRIAL ESTATE TO BE APPROVED TOWNSHIP: TOWNSHIPS AND DIVISION OF LAND ORDINANCE, 1963

In terms of Section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I declare the area being the subdivision of Farm No. 428 Brakwater, Registration Division "K" as indicated on General Plan No. K 455 and represented by Surveyor-General Plan (S.G No. A111/77) to be an approved township.

The conditions, subject to which the application for permission to establish the township concerned has been granted, are set out in the Schedule.

SCHEDULE

1. Name of township:

The township is called Brakwater Industrial Estate.

2. Composition of township:

The township comprises 42 erven numbered 1 to 42 and the remainder streets as indicated on General Plan K455 (S.G No. A111/77).

3. Reservation of Erven:

The Following erven are reserved for the local authority -

- (a) Erven 39 and 40 for municipal services; and
- (b) Erven 41 and 42 for purposes of public open spaces.

4. Conditions of title:

The following conditions are registered in favour of the local authority against the title deeds of all erven, except the erven referred to in paragraph 3 -

- (a) the erf must be used or occupied for purposes which are in accordance with, and the use or occupation of the erf must at all times be subject to, the provisions of the Windhoek Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance No.18 of 1954); and
- (b) the building value of the main building, including the outbuilding to be erected on the erf must be at least four times the prevailing valuation of the erf.

In terms of section 20(1)(a) and (c) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Roads Authority on behalf of the Permanent Secretary: Works and Transport proposes that, in the district of Swakopmund:

- (a) main road 44(a) as described in Schedule I and indicated by co-ordinates in Schedule II and shown by symbols A-B-C-D-E on sketch-map P2366 be proclaimed on land where no land previously existed;
- (b) district road 1918 be closed as described in Schedule III and shown on sketch-map P2366 by the symbols F-G;
- (c) district road 1994 be closed as described in Schedule IV and shown on sketch-map P2366 by the symbols H-I; and
- (d) district road 1999 be closed as described in Schedule V and shown on sketch-map P2366 by the symbols I-J.
