The Schedule to General Notice No. 176 of 11 May 2015 is amended by the substitution for paragraph 2 of the following paragraph:

"Amount of levy imposed

- **2.** The amount of the levy imposed is -
- (a) on petrol, 122 cents on every litre of petrol sold; and
- (b) on diesel, 122 cents on every litre of diesel sold.".
