AMENDMENT OF REGULATIONS UNDER ELECTRICITY ACT: ELECTRICITY ACT, 2007

Under section 43 of the Electricity Act, 2007 (Act No. 4 of 2007), I have made the regulations set out in the Schedule.

#### **SCHEDULE**

#### **Definitions**

1. In these regulations "the Regulations" means the Regulations made under the Electricity Act, 2007 (Act No. 4 of 2007) and published under Government Notice No. 13 of 16 February 2011.

#### Insertion of regulation 7A in the Regulations

**2.** The Regulations are amended by the insertion of the following regulation after regulation 7:

#### "Annual service fees

**7A.** The licensee must pay to the Board annual service fees as set out in the Annexure.".

### Substitution of Annexure to the Regulations

**3.** The Regulations are amended by the substitution for the Annexure of the following Annexure:
