AMENDMENT OF SOUTHERN AFRICAN CUSTOMS UNION MEMORANDUM OF UNDERSTANDING ON ROAD TRANSPORTATION REGULATIONS, 1998: CROSS-BORDER ROAD TRANSPORTATION ACT, 1996

Under section 5(1) of the Cross-Border Road Transportation Act, 1996 (Act No. 18 of 1996), I have amended the Regulations published under Government Notice No. 33 of 2 March 1998 as set out in the Schedule.

SCHEDULE

Definitions

1. In these regulations "the Regulations" means the Regulations made under the Southern African Customs Union Memorandum of Understanding on Road Transportation Regulations, 1998 published under Government Notice No. 33 of 2 March 1998 as amended by Government Notice No. 43 of 9 March 1998.

Amendment of regulation 3 of Regulations

- **2.** Regulation 3 of the Regulations is amended by the substitution of subregulation (1) for the following subregulation:
 - "(1) The applicant referred to in subregulation (2) shall submit the completed application forms together with a fee of N\$350.00 to the competent authority.".

Amendment of regulation 5 of Regulations

- **3.** Regulation 5 of the Regulations is amended by the addition of the following subregulation after subregulation (4):
 - "(5) A person -
 - (a) whose permit has expired as contemplated in subregulation (4) may renew the permit subject to the payment of N\$250.00 to the competent authority;
 - (b) who is already on the system with all the required information and has been issued a permit, will then be issued a renewal permit subject to the

compliance with paragraph (a).".

Amendment of regulation 7 of Regulations

- **4.** Regulation 7 of the Regulations is amended by the -
 - (a) substitution of subregulation (2) for the following subregulation:
- "(2) On receipt of information supplied under subregulation (1), the competent authority shall issue a duplicate permit on receipt of payment of a fee of N\$250.00 by the applicant."; and
 - (b) deletion of subregulation (4).

Amendment of Regulations

5. The Regulations are amended by the insertion of Annexure 1:
