### NOTICE OF INTENTION TO DECLARE COMMUNAL LAND AS HAMWEYI STATE FOREST RESERVE: FOREST ACT, 2001

Under section 13(2) of the Forest Act, 2001 (Act No. 12 of 2001), I -

- (a) give notice that I intend to declare the communal land, in respect of which the geographical boundaries are identified and described in Schedule 1, to be the Hamweyi State Forest Reserve;
- (b) invite any person who objects to the declaration referred to in paragraph (a) to, within 60 days of the publication of this notice in the Gazette, make written representations on the proposed declaration and management of the state forest reserve to the Director of Forestry, Ministry of Environment, Forestry and Tourism and the written representation must be submitted at -
  - Nkurenkuru District Forestry Office, Erf No. 83, Town Land Nkurenkuru, (i) Nkurenkuru; or

(ii) Room No. 305, Government Office Park, Ministry of Agriculture Building, Luther Street, Windhoek,

alternatively, the written representation must be submitted via registered mail for the attention of the Director, at Ministry of Environment, Forestry and Tourism, Private Bag 13306, Windhoek, to reach the Director within 60 days, and the objections must be made on the Form set out in Schedule 2;

- (c) give notice that if objections to the proposed declaration are not received by the Director within 60 days as contemplated in paragraph (b), I will proceed to declare the communal land referred to in paragraph (a) as the Hamweyi State Forest Reserve; and
- (d) give notice that the management plan for the proposed state forest reserve as well as details of how the revenue to be derived from the state forest reserve will be disposed of, can be obtained at the offices referred to in paragraph (b).

# BOUNDARY DESCRIPTION OF COMMUNAL LAND TO BE DECLARED AS HAMWEYI STATE FOREST RESERVE: KAVANGO WEST REGION


Hamweyi State Forest Reserve is located about 45km from Rundu along the Rundu-Karukuvisa gravel road in the Ncuncuni Constituency of the Kavango West region. The state forest reserve starts at point A in the north-west corner and extends to the north-east direction linking point B to point C. From point C it runs in the south-east direction to point D and changes inward east direction to point E. From point E it continues in the south direction to point F and then changes its direction outward east direction to point G. From point G it stretches south to point H and forms a south-east corner near Hamweyi Forestry Research Station and institutional workers residential area. From point H it changes its direction to the west passing through points I and J and linking to point K in the south-west corner. From point K it links to point A. The border is marked with cleared cutlines used as firebreak all around the state forest reserve. Geographically, the state forest reserve borders with Okavango drainage and Karukuvisa gravel road consisting of various villages including Madudu, Ncuncuni, Cencwa, Gcundu, Bamu-Bamu, Hamweyi as well as other villages in the Kavango East region on the east, Ncumcara Community Forest on the west, Naute Community Forest on the east and extends to Otjozondjupa region on the south.

# NOTICE OF INTENTION TO DECLARE COMMUNAL LAND AS KANOVLEI STATE FOREST RESERVE: FOREST ACT, 2001

Under section 13(2) of the Forest Act, 2001 (Act No. 12 of 2001), I -

(a) give notice that I intend to declare the communal land, in respect of which the geographical boundaries are identified and described in Schedule 1, to be the Kanovlei State Forest Reserve;

- (b) invite any person who objects to the declaration referred to in paragraph (a) to, within 60 days of the publication of this notice in the *Gazette*, make written representations on the proposed declaration and management of the state forest reserve to the Director of Forestry, Ministry of Environment, Forestry and Tourism and the written representation must be submitted at -
  - (i) Grootfontein District Forestry Office, Stevenson Street, Grootfontein; or
  - (ii) Room No. 305, Government Office Park, Ministry of Agriculture building, Luther Street, Windhoek,

alternatively, the written representation must be submitted via registered mail for the attention of the Director, at Ministry of Environment, Forestry and Tourism, Private Bag 13306, Windhoek, to reach the Director within 60 days, and the objections must be made on the Form set out in Schedule 2;

- (c) give notice that if objections to the proposed declaration are not received by the Director within 60 days as contemplated in paragraph (b), I will proceed to declare the communal land referred to in paragraph (a) as the Kanovlei State Forest Reserve; and
- (d) give notice that the management plan for the proposed state forest reserve as well as details of how the revenue to be derived from the state forest reserve will be disposed of, can be obtained at the offices referred to in paragraph (b).

# BOUNDARY DESCRIPTION OF COMMUNAL LAND TO BE DECLARED AS KANOVLEI STATE FOREST RESERVE: OTJOZONDJUPA REGION


Kanovlei State Forest Reserve is located in the Tsumkwe Constituency of the Otjozondjupa region situated about 180km from Grootfontein along the Grootfontein -Tsumkwe gravel road. The border starts at point A forming the west corner at the Grootfontein - Tsumkwe gravel road (C44). It runs in the northern direction to point B where it borders with the Ranch Farm Plot and the Rest Camp village on the west side. From point B it runs in the east direction to point C where it borders with Kanovlei village and extends to Kavango West region on the north side. From Point C it runs in the south direction to point D at the Grootfontein - Tsumkwe gravel road (C44) where it borders with Camelhoud Farm in the east. From point D it runs to the west along the Grootfontein-Tsumkwe gravel road (C44) passing through points E, F, G, and H to point A. Geographically, the state forest reserve borders with Kanovlei village in the West, N ≠a Jaqna Community Forest and Conservancy and M'Kata Community Forest in the south and Kavango West region in the north.
