Supreme Court <i>ad hoc</i> Judge	Salary equal to that of a Supreme Court Judge proportionate to the period during which he or she acts as <i>ad hoc</i> Judge
Deputy Judge-President	1 557 739.40
High Court Judge	1 435 931.40
High Court Acting Judge	Salary equal to that of a High Court Judge proportionate to the period during which he or she acts as Acting Judge
